BY-LAW # 28

A BY-LAW TO AUTHORIZE A SUBMISSION TO THE OWNERS OF LAND WITHIN ELECTORAL AREA "A", AS DEFINED IN THE LETTERS PATENT OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN ON THE QUESTION OF PARTICIPATION IN THE FUNCTION OF A GARBAGE DISPOSAL FACILITY.

WHEREAS the Regional Board of the Regional District of Central Okanagan has been requested to undertake a garbage disposal facility for Electoral Area "A" and,

WHEREAS Supplementary Letters Patent dated January 27, 1970 grants the power of garbage disposal to the Regional District of Central Okanagan for the participating member municipalities of Electoral Areas B, C, D, E, F, and the defined areas of Electoral areas "I" and "G" and

WHEREAS the estimated costs of providing the garbage disposal facility is approximately \$16,000.00 (which from year to year may vary, dependent upon the cost of operating and maintaining the said garbage disposal facility to the Electoral Areas and

WHEREAS the Regional Board of the Regional District of Central Okanagan has recovered the annual costs by levying in the manner prescribed in the Municipal Act of the mill rate sufficient therefore to provide the sum required for each year commencing with the year 1970 on land and improvements on the basis of assessment fixed for school purposes excluding property that is taxable for school purposes only by special act, provided however, that the Regional Board may, by By-law, with the approval of the Inspector of Municipalities, provide that the amount requisitioned shall be assessed and levied on improvements only, once adequate facilities are available to accommodate a levy in this manner and

WHEREAS Electoral Area "A" of the Regional District of Central Okanagan has requested authority to participate in the said garbage disposal facility

NOW THEREFORE THE Regional Board of the Regional District of Central Okanagan in an open meeting assembled enacts as follows:


- (1) A poll shall be taken of the owners of land qualified to vote within Electoral Area "A", in accordance with the provisions of the Municipal Act to determine whether or not the owners of land wish to participate with the other member municipalities in the function of a Garbage Disposal Facility.
- (2) The poll shall be taken on the 3rd day of December, 1970, between the hours of 8 o'clock in the forenoon and 8 o'clock in the afternoon.
- (3) An advanced poll shall be conducted at the office of the Regional District of Central Okanagan, 540 Groves Avenue, Kelowna, British Columbia, between the hours of 9 o'clock in the forenoon and 5 o'clock in the afternoon on Tuesday the 1st day of December 1970, and those permitted to vote, sign a statement that they expect to be absent from the area on polling day or they are for reasons of conscience prevented from voting on polling day.
- (4) The question on the ballot shall read:
Are you in favour of sharing jointly and in cooperation with other member municipalities within the Regional District of Central Okanagan an estimated annual cost of approximately \$16,000.00 said amount being based upon the estimated cost for the year 1970, which may from time to time be revised thereafter, to meet contractual obligations of the Regional District, on behalf of said member municipalities, to the City of Kelowna for the use of Garbage Disposal Facility to service the said member municipalities.
- (5) This By-law may be cited as "THE GARBAGE DISPOSAL FACILITY ELECTORAL AREA "A" PARTICIPATION REFERENDUM BY-LAW # 28".
