Being a By-law to amend the boundaries of the Specified Area within Electoral Area H of the Regional District of Central Okanagan for the purpose of providing Street Lights.

WHEREAS the Regional Board of the Regional District of Central Okanagan has been requested to enlarge the specified area for the purpose of providing street lighting to the community of Westbank;

AND WHEREAS it is deemed desirable to include additional lands within the said specified area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The boundaries of the said specified area as established by By-law No. 52, cited as the "Westbank Street Light Specified Area Establishment By-law, No. 52, 1971", are hereby extended to include all those lands as defined and outlined in Schedule 'A' attached to and forming part of this By-law.
2. This By-law may be cited for all purposes as "The Westbank Street Light Specified Area Amendment By-law, No. 79, 1974".

Schedule "A" - Specified Area - Street Lighting

By Law No. 79.

Commencing at the most southerly southwest corner of Indian Reserve No. 9 (Tsintikeptun), Osoyoos Division of Yale District, being a point on highwater mark of Okanagan Lake on the westerly shore thereof; thence northerly, westerly and northerly along the westerly, southerly and westerly boundaries of said Indian Reserve No. 9 (Tsintikeptun) to the most westerly northwest corner thereof; thence westerly along the northerly boundaries of Lots 36 and 37 of Lot 805, Registered Plan 761 on file in the Land Registry Office, Kamloops, to the southeast corner of Lot 1, Lot 804, Registered Plan 23979; thence northerly along the easterly boundary of said Lot 1, Plan 23979 to the northeast corner thereof; thence westerly along the northerly boundaries of Lot 1, Plan 23979, Lot A, Registered Plan 18841, and Lots 7 and 6, Registered Plan 1414 respectively, all of Lot 804 to the most westerly corner of said Lot 6 Plan 1414, being a point on the easterly limit of Smith Creek Road; thence westerly in a straight line to the most northerly northeast corner of Lot 1, Lot 804, Registered Plan 11041; thence westerly along the northerly boundaries of Lot 1, Plan 11041, and Parcel A of Lot 804, Registered Plan 5239, to the northeast corner of said Parcel A, Plan 5239 being a point on the easterly limit of Harold Road; thence westerly along the northerly boundaries of Lots 804 and 2697 to the northwest corner of Lot 2697; thence southerly along the westerly boundary of said Lot 2697 to the most northerly northeast corner of Lot 3796; thence westerly, southerly and easterly along the northerly westerly and southerly boundaries of said Lot 3796 to the northwest corner of Lot 19, of Lot 3189, Registered Plan 1256; thence southerly along the westerly boundary of said Lot 19 to the southwest corner thereof; thence westerly along the southerly boundary of Lot 20, of Lot 3189, Plan 1256, and continuing westerly along the westerly prolongation thereof to the point of intersection with the centreline of Glenrosa Road as constructed on the ground; thence southeasterly along said centreline of Glenrosa Road to the point of intersection with the northerly prolongation of the westerly boundary of Lot 3 of Lot 3189 Registered Plan 16117; thence southerly along said prolongation to the northwest corner of said Lot 3; thence southerly along the westerly boundary of

said Lot 3 to the southwest corner thereof; thence easterly along the northerly boundary of Lot 3482, to the northeast corner thereof; thence southerly and westerly along the easterly and southerly boundaries of Lot 3482 to the northwest corner of Lot 2, Lot 3188, Registered Plan 1885; thence southerly along the westerly boundaries of Lot 2, Plan 1885 and of Lot 1, of Lot 3188, Registered Plan 16695, to the southwest corner of said Lot 1, Plan 16695; thence easterly along the southerly boundary of Lot 1, Plan 16695 and continuing easterly along the easterly prolongation thereof to the point of intersection with the centreline of Highway 97, Registered Plan H911; thence northeasterly along said centreline of Highway 97, Plan H911 to the point of intersection with the northerly prolongation of the westerly boundary of Lot 7 of Lot 3188, Plan 1885; thence southerly along said northerly prolongation to the most westerly northwest corner of said Lot 7, Plan 1885; thence southerly along the westerly boundary of Lot 7, Plan 1885, to the southwest corner thereof; thence easterly and northerly along the southerly and easterly boundaries of Lot 3188 to the northwest corner of Lot 3187; thence easterly and southerly along the northerly and easterly boundaries of Lot 3187 to the southwest corner of Lot 807; thence easterly along the southerly boundary of said Lot 807 to the southeast corner thereof; thence southerly along the westerly boundary of Lot 5075 to the southwest corner thereof; thence southerly along the westerly boundary of that part of Lot 487 shown outlined in red on Registered Plan 6926 to the southwest corner thereof; thence westerly and southerly along the northerly and westerly boundaries of that part of Lot 487 shown outlined in red on Registered Plan B 6446 to the southwest corner thereof; thence southerly and easterly along the westerly and southerly boundaries of that part of Lot 487 shown outlined in red on Registered Plan B 7147 to the most southerly northeast corner of Lot 1, Lot 487, Plan 2575; thence southerly along the easterly boundary of said Lot 1 and continuing southerly along the southerly prolongation thereof to the point of intersection with the centreline of Gellatly Road; thence northwesterly along said centreline to the point of intersection with the northeasterly prolongation of the centreline of Whitworth Road as constructed on the ground; thence southwesterly along said northeasterly prolongation and continuing in a general southwesterly and westerly direction along said centreline of Whitworth Road to the point of intersection with the northerly prolongation of the westerly boundary of Lot 16, of Lot 487, Registered Plan 8345; thence southerly along said northerly prolongation to the most northerly

corner of said Lot 16, Plan 3345; thence southerly along the westerly boundary of said Lot 16, Plan 3345, to the most westerly corner thereof, being a point on the highwater ^{MARK} of Okanagan Lake on the westerly shore thereof; thence in a general easterly, northerly and easterly direction along said highwater mark to the aforesaid most southerly southwest corner of Indian Reserve No. 9 (Tsintikeptum), Osoyoos Division of Yale District, being the point of commencement.
