BY-LAW NO. 156

Being a by-law to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 110, 1975

---


WHEREAS it is deemed necessary to amend the Impounding fees as established in the Central Okanagan Dog Regulations and Impounding By-law No. 110, 1975;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. That Clause 17, (a) to (d) inclusive be amended by repealing and substituting it with the following wording:
  - (17) The owner of any dog impounded pursuant to the provisions of this by-law may reclaim such dog on application to the poundkeeper at any time prior to its sale or destruction on proof of ownership and on payment of the following charges:-
    - (a) If the license for the current year for the dog has been taken out by the owner, pursuant to this by-law, a sum not exceeding Fifteen (\$15.00) dollars for first impoundment.
    - (b) If no license for the current year for the dog has been taken out by the owner, pursuant to this by-law, the prescribed license fee plus a sum not exceeding Twenty (\$20.00) dollars for first impoundment.
    - (c) For the second and each additional impoundment of the same dog, a sum not exceeding Twenty-five (\$25.00) dollars.
    - (d) In addition to the charges as set forth in sub-section (a) and (b) of this provision, a maintenance and sustenance fee of Three (\$3.00) dollars for each twenty-four hour period the dog has remained in the pound will be charged.
2. This by-law may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 156 , 1978".






