

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 178

Being a by-law to amend the by-law cited as "Regional District of Central Okanagan Building By-law No. 65, 1973"

WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary and expedient to amend the Regional District of Central Okanagan Building By-law No. 65, 1973;

NOW THEREFORE THE BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. By-law No. 65, cited as "Regional District of Central Okanagan Building By-law No. 65, 1973" is hereby amended by

- (a) adding the following to Clause 2, Definition:

"Retaining Wall" shall mean a wall constructed of concrete, steel, treated wood, stone, masonry, brick, concrete block or a combination thereof, designed so as to support, confine, retain or keep in place earth material

- (b) by adding the following as Clause 4(6):

- I No person shall construct a retaining wall greater than 1.22 m (4 feet) in height without first obtaining a permit issued by the authority having jurisdiction.

- II Upon application, the authority having jurisdiction may require that the application for a permit for a retaining wall be accompanied by plans designed and certified by a professional engineer.


2. This by-law may be cited for all purposes as the Regional District of Central Okanagan Building Amendment By-law No. 178, 1979.
