

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 204

---

Being a by-law to authorize shopping on a holiday as defined in The Holiday Shopping Regulation Act.

---

WHEREAS the Holiday Shopping Regulation Act prohibits carrying on retail business or admittance of the public to a retail establishment on a holiday except -

- a) as permitted under Section 11 of the Lord's Day Act (Canada)
  - b) in respect of a scheduled business as defined in the Holiday Shopping Regulation Act.
  - c) as permitted by by-law of a Regional District adopted in accordance with the Holiday Shopping Regulation Act.
- or
- d) as permitted in an order of the Lieutenant - Governor-In-Council under Section 7 of the Holiday Shopping Act.

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it desirable to adopt a by-law under Section 3 of the Holiday Shopping Act so as to permit a retail business, which sells food-stuffs, newspapers, periodicals and sundries in a total sales and display area open to the public of greater than 225 square metres and employing more than four (4) persons to serve the public in the retail establishment within Electoral Area H

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. Any person may, in respect of any retail business located in Electoral Area H which sells or offers for sale to the public only food-stuffs, newspapers, periodicals and sundries in a sales and display area which is open to the public of greater than 225 square metres and which employs more than 4 persons to serve the public therein:
  - i) carry on the said retail business;
  - ii) sell or offer for sale the said goods and services in the said retail establishment;
  - iii) admit the public to the said retail establishment; on a holiday.


- 2. This by-law applies to Electoral Area H as defined and outlined in the Letters Patent of the Regional District of Central Okanagan.
- 3. This by-law shall come into force on January 1st, 1981.
- 4. This by-law may be cited as "The Regional District of Central Okanagan Holiday Shopping Regulation By-law No. 204,1980".






