

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 208

Being a by-law to authorize the entering into of an annual operating agreement for transit services

WHEREAS the Regional District of Central Okanagan has been authorized to undertake a transit function pursuant to the Urban Transit Authority Act and the Urban Transit Authority of British Columbia has established a transit service area being an area including Electoral Area 'H' and the defined area of Electoral Area 'G' as specified in the Transit Service Agreement;

AND WHEREAS the Regional District of Central Okanagan has entered into a Transit Service Agreement with the Urban Transit Authority of British Columbia;

AND WHEREAS the Urban Transit Authority Act provides that where the Urban Transit Authority of British Columbia contracts for a transit service it shall negotiate with Independent Bus and Transportation Inc. or its successor and an affected municipality with a view to entering into an annual operating agreement respecting the provisions of transit services;


NOW THEREFORE THE BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN, in open meeting assembled, enacts as follows:



The board hereby approves the entering into by the Regional District of Central Okanagan an annual operating agreement with the Urban Transit Authority of British Columbia and Independent Bus and Transportation Inc. substantially in the form of the agreement presented to the meeting and marked by the Administrator and that the seal of the Regional District of Central Okanagan be affixed to the Agreement in the presence of the Chairman and the Administrator.
2. This by-law may be cited as the "Annual Operating Agreement Authorization By-law No. 208, 1981"




