BY-LAW NO. 241

Being a by-law to authorize the Extension of a Specified Area within Electoral Area 'I' of the Regional District of Central Okanagan.

WHEREAS by By-law No. 214, the Scotty Heights Subdivision Specified Area for streetlights was established to provide streetlights to the said Specified Area;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to extend the boundaries of the said Specified Area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1. The boundaries of the Specified Area of Electoral Area 'I' defined by By-law No. 214 being the "Scotty Heights Sub-division Specified Area By-law No. 214, 1981" is hereby extended to include the lands more particularly described in Schedule 'A' attached hereto.
2. Schedule 'A' referred to in Section 1(a) of By-law No. 214 is hereby deleted and Schedule 'B' attached hereto is substituted therefore.
3. This by-law is cited as the 'Scotty Heights Streetlights Extension By-law No. 241, 1982'.





By-law No. 241

Regional District of Central Okanagan

Commencing at the northwest corner of Lot C of Section 12, Township 23, Osoyoos Division of Yale District, Registered Plan 30526 on file in the Land Title Office, Kamloops; thence northerly along the westerly boundary of Lot B of Section 12 Township 23, Plan 30526 to the northwest corner thereof; thence westerly along the southerly boundaries of Lots 2 and 3 of Section 12, Township 23, Registered Plan 475 to the northeast corner of Lot A of Section 12, Township 23, Registered Plan 23162; thence southerly along the easterly boundaries of Lots A, B, and C of Section 12, Township 23, Plan 23162 to the southwest corner of Lot A of Section 12, Township 23, Registered Plan 30526; thence easterly and northeasterly along the southerly and southeasterly boundary of said Lot A, Plan 30526 to the most easterly southeast corner thereof; thence northerly along the westerly boundary of Lot C of Section 12, Township 23, Plan 30526 to the aforesaid northwest corner thereof, being the point of commencement.

Commencing at the southeast corner of Lot 2 of Section 12, Township 23, Osoyoos Division of Yale District, Registered Plan 4660 on file in the Land Title Office, Kamloops; thence easterly in a straight line to the southwest corner of Lot 1 of Section 12, Township 23, Registered Plan 30525; thence easterly along the southerly boundaries of Lots 1 to 10, inclusive, of Section 12, Township 23, Plan 30525 to the southeast corner of said Lot 10, Plan 30525; thence easterly in a straight line to the southwest corner of Lot 11 of Section 12, Township 23, Registered Plan 22671; thence easterly along the southerly boundaries of Lots 11 to 19, inclusive, of Section 12, Township 23, Plan 22671 to the southeast corner of said Lot 19, Plan 22671; thence northerly along the easterly boundary of Section 12, Township 23 to the southeast corner of Lot B of Section 12, Township 23, Registered Plan 30526; thence westerly and northerly along the southerly and westerly boundaries of said Lot B, Plan 30526 to the southeast corner of Lot C of Section 12, Township 23, Plan 30526; thence westerly and northerly along the southerly and westerly boundaries of said Lot C, Plan 30526 to the northwest corner thereof; thence northerly along the westerly boundary of Lot B of Section 12, Township 23, Plan 30526 to the northwest corner thereof; thence westerly along the southerly boundaries of Lots 2 and 3 of Section 12, Township 23, Registered Plan 475 to the northeast corner of Lot A of Section 12, Township 23, Registered Plan 23162; thence southerly along the easterly boundaries of Lots A, B, C, and D of Section 12, Township 23, Plan 23162 and Lot 2 of Section 12, Township 23, Plan 4660 to the aforesaid southeast corner of said Lot 2, Plan 4660, being the point of commencement.
