

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 299

Being a bylaw to provide for remuneration of Directors and Alternate Directors

WHEREAS the provisions of Section 788, subsections (1) and (2) of the "Municipal Act" R.S.B.C. 1979, Chapter 290 provides that the Regional Board may by bylaw provide for the remuneration of Directors as follows:

1. The Regional Board may by bylaw provide
 - (a) for remuneration of directors and alternate directors;
 - (b) for additional remuneration for the chairman;
 - (c) for remuneration for members of committees of the regional board for each regularly constituted committee meeting attended, and the bylaw may limit the number of meetings for which remuneration may be paid.
2. A director or alternate director is entitled to be reimbursed for reasonable expenses incurred by him in connection with his attendance at meetings of the regional board. A director, alternate director or other committee member is entitled to that reimbursement in connection with attendance at committee meetings specified in subsection (1) (c) and engaging in business of the regional district specifically authorized by the regional board.

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1. The Chairman of the Board of Directors is entitled to receive:
 - a) A monthly remuneration of one thousand, five hundred dollars (\$1,500.00)
2. Directors, other than the Chairman, are entitled to receive:
 - a) A monthly remuneration of Five hundred dollars (\$500.00)
3. Alternate Directors are entitled to received remuneration of Sixty-Five Dollars (\$65.00) for each Regional Board meeting attended.
4. All directors, alternate directors, including the Chairman, are entitled to receive:
 - a) Thirty dollars (\$30.00) for each half day regularly constituted committee meeting attended and sixty dollars (\$60.00) for each full day regularly constituted committee meeting attended.
 - b) Reasonable expenses incurred by him/her for attending meetings of the Regional Board, Committee Meetings and engaging in business of the Regional District specifically authorized by the Board.
 - c) Mileage for the use of their privately owned automobile while engaging in business of the Regional District at the following rates:

- 25 cents per km. for cars and light pick-up trucks.

- 28 cents per km. for 4 wheel drive trucks and heavy duty pick-up trucks.

By-law #270, cited as the Regional District of Central Okanagan Board of Directors Remuneration By-law #270, 1984 is hereby repealed.


This by-law may be cited as the Regional District of Central Okanagan Board of Directors Remuneration Bylaw #299 , 1985.




