BY-LAW NO. 306

Being a by-law to amend the Regional District of Central Okanagan Noxious Insect Control By-law No. 128, 1977.

WHEREAS it is deemed necessary to amend the Regional District of Central Okanagan Noxious Insect Control By-law No. 128, 1977;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. That "(I) INTERPRETATION" of By-law 128 is hereby amended by repeating and replacing the interpretation of "INSPECTOR" with the following:

"INSPECTOR" shall mean the Inspector appointed by the Administrator at any time or from time to time to enforce and carry out the provisions of this By-law and shall also include the fieldmen of the following Fruit Packinghouses:
