

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 386

Being a By-law to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 366, 1988.

WHEREAS it is deemed necessary to amend the Central Okanagan Dog Regulation and Impounding By-law No. 366, 1988.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

THAT Part IV Impounding of Dogs be amended as follows:

1. To amend Section 31(a) to read as follows:

"An impounding fee of Twenty-five Dollars (\$25.00) for the first impoundment; Fifty dollars (\$50.00) for the second impoundment; One Hundred dollars (\$100.00) for the third impoundment; One hundred and Fifty Dollars (\$150.00) for the fourth and subsequent impoundments and applicable license fee if the dog is unlicensed."

2. To amend Section 43(b) to read as follows:

"The pecuniary penalties to be indicated in the form of the ticket set out as Schedule "B" to this bylaw shall be as follows:

(i) For the first offence by the person in question, the sum of \$25.00;

(ii) For the second offence by the person in question, the sum of \$50.00;

(iii) For the third offence by the person in question, the sum of \$100.00;

(iv) For the fourth or subsequent offence by the person in question, the sum of \$150.00."


7. This by-law may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 386, 1989".
