Re: Joe Rich Community Parks Specified Area  
Establishment Repealing Bylaw No. 392, 1989 and  
Ellison Community Parks Specified Area  
Establishment Repealing Bylaw No. 393, 1989

The above bylaws have been favourably reviewed from both an administrative and financial perspective. However, before proceeding with a recommendation to the Minister for approval under section 319 of the Municipal Act, we have noted that valid adoption of the bylaws would have had to occur prior to July 31, 1989, the effective date of the new regional district legislation.

As your next regional board meeting falls in August 1989, we recommend the following solution: Under the new Part 24 any existing specified area service or function not converted by an establishing bylaw to a service, as defined by the new legislation, within five years will automatically cease to be effective. The regional district can choose not to exercise the powers authorized by Bylaws numbered 228 and 194 and therefore not requisition any funds under them.

Accordingly, Bylaws numbered 392 and 393 are returned. Please do not hesitate to call this office if you have any further questions.

BYLAW NO. 392

Being a bylaw to repeal the Joe Rich Community Parks Specified Area Establishment Bylaw No. 228, 1982.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted Bylaw No. 228 on the 5th day of April, 1982, which is cited as the "Joe Rich Community Parks Specified Area Establishment Bylaw No. 228, 1982";

AND WHEREAS Bylaw No. 228 empowered and authorized the Regional Board to establish in Electoral Area 'I' a specified area for the purpose of operating and maintaining the Joe Rich Community Park in and for the said specified area;

AND WHEREAS the Regional Board subsequently, by Supplementary Letters Patent, issued on the 14th day of July, 1982, Electoral Area 'I' was included in the function of Community Parks;

AND WHEREAS it is deemed necessary to repeal Bylaw No. 228

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. That Bylaw No. 228 cited as "Joe Rich Community Parks Specified Area Establishment Bylaw No. 228, 1982" be hereby repealed.
2. This bylaw may be cited as the "Joe Rich Community Parks Specified Area Establishment Repealing Bylaw No. 392, 1989".
