

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 411

A bylaw to establish a local service within portions of Electoral Area "A" to provide for sewer service.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing sewer service to portions of Electoral Area "A";

AND WHEREAS, in accordance with Section 795(2)(a)(ii) of the Municipal Act, the Regional Board has received a sufficient petition for the service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area "A", a local service for the purpose of providing sewer service within the boundaries of the service area shown outlined on the plan attached as Schedule "A" to this bylaw and commonly known as "Carr's Landing/Nuyens Sewer Local Service Area".
2. The amount of monies expended for annual operating costs for the service provided under Section 1 shall not exceed ten thousand (\$10,000) dollars.
3. The annual operating costs shall be recovered by requisition of monies to be collected by user fees.
4. This bylaw may be cited as "Carr's Landing/Nuyens Sewer System Local Service Area Establishment Bylaw No. 411, 1990."

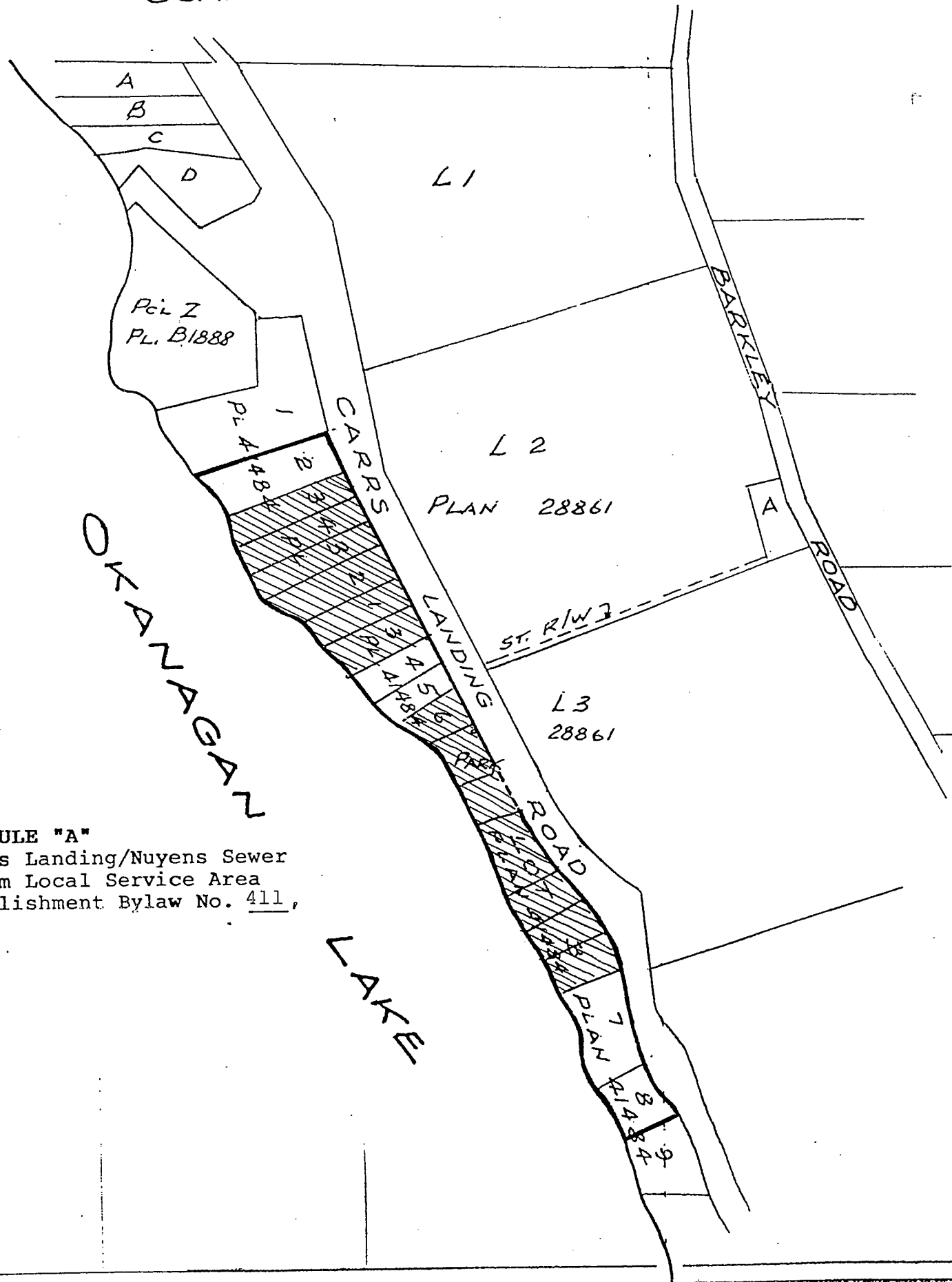

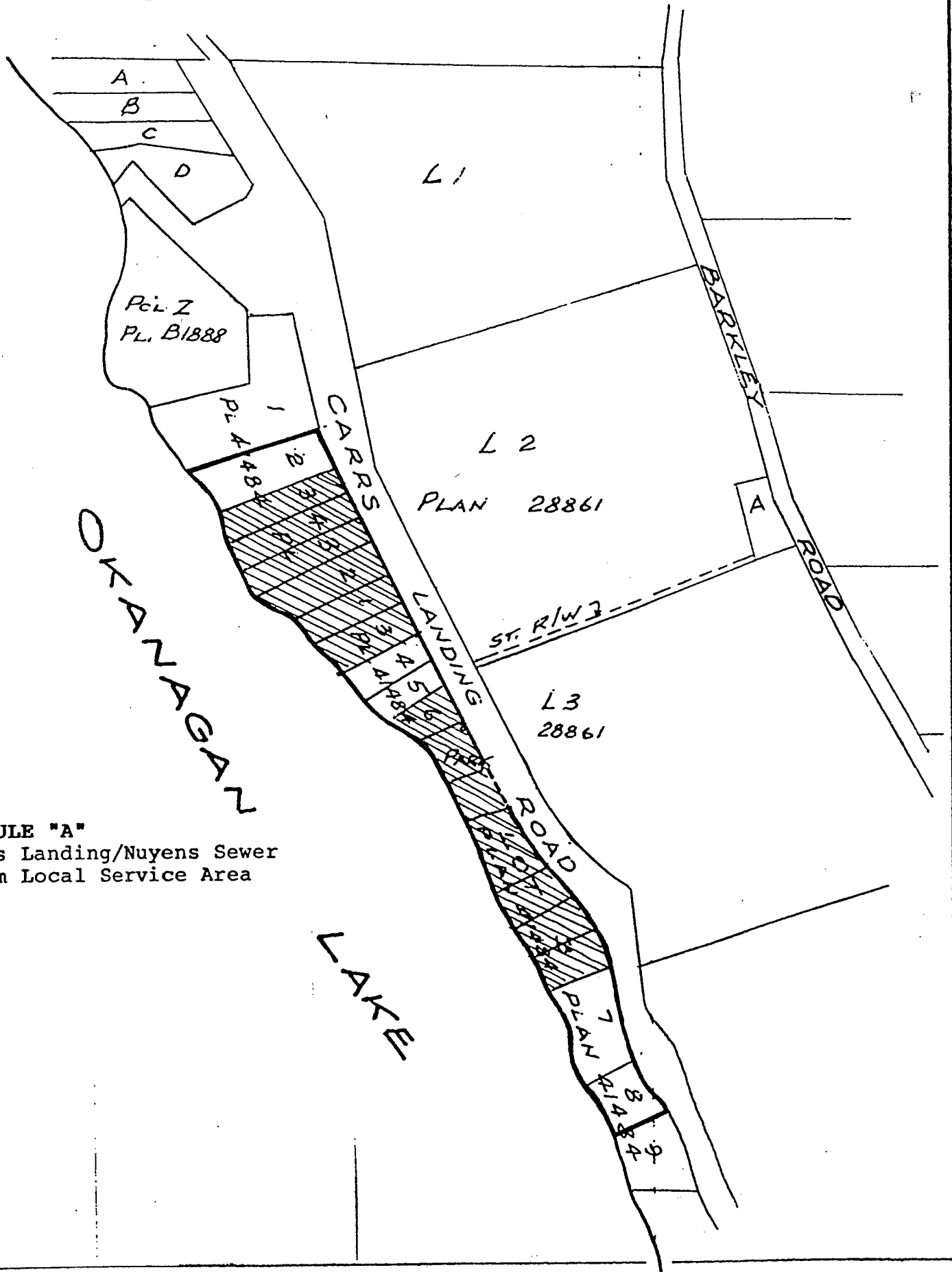
