

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 435

TICKET INFORMATION UTILIZATION

WHEREAS Section 934.1(1)(a) of the Municipal Act empowers the Regional Board, by bylaw, to designate those bylaws for which municipal ticket information may be used as means of bylaw enforcement;

AND WHEREAS Section 934.1(1)(c) of the Municipal Act empowers the Regional Board to, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a bylaw;

AND WHEREAS Section 934.1(10) of the Municipal Act empowers the Regional Board to, by bylaw, set fine amounts in consultation with the Chief Judge of the Provincial Court;

AND WHEREAS the Regional Board deems it expedient to authorize the use of municipal ticket information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences and to set certain fine amounts.

NOW, THEREFORE, the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The bylaws listed in Column 1 of Schedule 1 to this Bylaw, as amended from time to time, may be enforced by means of a ticket in the form prescribed for the purpose of Section 934.1(1)(a) of the Municipal Act.
2. The persons appointed to the job positions or titles listed in Column 2 of Schedule 1 to this Bylaw are designated as bylaw enforcement officers pursuant to Section 934.1(1)(b) of the Municipal Act for the purpose of enforcing the bylaws listed in Column 1 of Schedule 1 opposite the respective job positions.
3. The words or expressions set forth in Column 1 of Schedules 2 through 7 to this Bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.
4. The amounts appearing in Column 3 of Schedules 2 through 7 to this Bylaw are the fines set pursuant to Section 934.1(6) of the Municipal Act for the corresponding offences designated in Column 1.
5. This Bylaw may be cited as "Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435,1990".
6. This Bylaw shall take effect upon the date of its adoption.




