

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 459

A bylaw to establish a local service within a portion of Electoral Area "H" to provide for sewer service.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing sewer service to a portion of Electoral Area "H";

AND WHEREAS, in accordance with Section 795(2)(a)(ii) of the Municipal Act, the Regional Board has received a sufficient petition for the service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:


1. The Regional District hereby establishes within Electoral Area "H", a local service for the purpose of providing sewer service within the boundaries of the service area shown outlined on the plan attached as Schedule "A" to this bylaw and commonly known as "Pritchard Drive Sewer System Local Service Area".
2. The amount of monies that may be requisitioned for annual operating and debt servicing costs for the service provided under Section 1 shall not exceed Sixty Thousand dollars (\$60,000.00)
3. The annual operating costs shall be recovered by requisition of monies to be collected by user fees.
4. The annual debt servicing costs shall be recovered by requisition of monies to be collected by the application of a parcel tax levied on all parcels within the Local Service Area.
5. This bylaw may be cited as "Regional District of Central Okanagan Pritchard Drive Sewer System Local Service Area Establishment Bylaw No. 459 , 1991".
