BYLAW NO. 479

Being a by-law to amend the Regional District of Central Okanagan Unsightly Premises Extended Service Establishment Bylaw No. 409, 1990.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Unsightly Premises Extended Service Establishment Bylaw No. 409, 1990;

AND WHEREAS the Regional Board deems it advisable to amend the said bylaw;

NOW THEREFORE, the Regional Board of the Regional District of Central Okanagan enacts as follows:

1. THAT Section 3 of Bylaw No. 409, cited as "Unsightly Premises Extended Service Establishment Bylaw No. 409, 1990," be amended to read:

"The annual costs of providing the service described in Section 1 and 2 shall be recovered by a requisition of money pursuant to Section 809.1 of the Municipal Act to be collected pursuant to Section 810.1 by a property value tax to be levied and collected on the assessed value of improvements only within the service area."

2. THAT Section 4 of Bylaw No. 409 be renumbered to Section 5 and a new Section 4 be inserted to read:

"The costs of providing the service that will be paid for by amounts requisitioned under Section 809.1 of the Municipal Act shall be apportioned among the participating areas on the basis of the converted value of improvements only in those areas."

3. This bylaw may be cited for all purposes as "The Regional District of Central Okanagan Unsightly Premises Extended Service Amending Bylaw No. 479 , 1991."


