BYLAW NO. 481

Being a bylaw to amend a Local Service Area.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted and established the Carr's Landing, Coral Beach, Juniper Cove Fire Protection Local Service Area under Bylaw No. 417, 1990.

AND WHEREAS it is deemed necessary to amend the said Local Service Area;

AND WHEREAS as a sufficient petition has been received by the Regional District of Central Okanagan for those lands to be added to the Carr's Landing, Coral Beach, Juniper Cove Fire Protection Local Service Area;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:



The boundaries of the Carrs Landing, Coral Beach, Juniper Cove Fire Protection Local Service Area created by the Bylaw cited as "The Carrs Landing, Coral Beach, Juniper Cove Fire Protection Local Service Establishment Bylaw No. 417, 1990" are hereby extended to include the lands more particularly described in Schedule 'B' attached hereto.
2. Schedule 'A' of Bylaw No. 417 is hereby amended to include the lands shown on Schedule 'B' attached hereto.
3. This bylaw may be cited as "The Regional District of Central Okanagan Carrs Landing, Coral Beach, Juniper Cove Fire Protection Local Service Amending Bylaw No. 481, 1991"




