BYLAW NO. 490

---

Being a bylaw to establish, maintain and operate an Economic Development Commission.

---

WHEREAS by Letters Patent, the Regional District of Central Okanagan is authorized to establish, maintain and operate an Economic Development Commission;


AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it advisable to establish, maintain and operate an Economic Development Commission;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan enacts as follows:

1. That an Economic Development Commission be established.
2. The annual net costs for the operation and maintenance of the Economic Development Commission shall be apportioned on the basis as set out in the Letters Patent.
3. **Structure**
  1. That the Economic Development Commission shall be comprised of the following:
    - a) The Chairperson shall be appointed by the Regional Board who may be a Regional Board Director or from the community at large.
    - b) One representative of the Chamber of Commerce from each of the City of Kelowna, the District of Peachland, Westbank and Winfield, or alternatively, a business association within these communities if there is not a registered Chamber of Commerce.
    - c) One elected local government representative from the City of Kelowna, the District of Peachland and one Director from an Electoral Area of the Regional District.
    - d) Up to 16 other persons, nominated or by individual application, representing various economic sectors within the Regional District.
    - e) The Economic Development Commission Board of Directors shall be comprised of the following:
      - i. 1 Director of the Regional District of Central Okanagan
      - ii. 1 Director - City of Kelowna
      - iii. 1 Director - District of Peachland
      - iv. 1 Director - Chamber of Commerce or business association together with 3 directors elected from the Commission.

- f) The Executive Committee shall comprise:
    - i. The Chairman of the Economic Development Commission,
    - ii. One Commission Board Representative, elected by the Commission Board,
    - iii. Three representatives elected from and by the Economic Development Commission as a whole;
  - g) The Economic Development Commission shall appoint one alternate representative for each of the three commission representatives on the Executive Committee;
  - h) The alternate representative may take the place of an absent commission representative, and vote and generally act on all matters in the absence thereof.
  - i) The Chairman of the Regional District of Central Okanagan is Ex Officio Member to the Economic Development Commission.
4. The Board of Directors may from time to time appoint or establish standing or special committees to consider specific matters of concern or interest. Said committees shall consist of no less than three (3) members, including one member of the Board of Directors and two members of the other members of the Commission. The Commission "Board of Director" member shall be the Committee Chairman who shall report the activities of the Committee as required.
5. The organizational structure of the Commission shall be as outlined in Exhibit "A" attached to this bylaw.
6. The Regional Board may from time to time, as deemed necessary, appoint a Director of Economic Development and support staff to carry out instructions and policies of Commission Executive.
7. A budget shall be prepared annually by the Commission Executive and submitted to the Regional Board for consideration and approval.
8. This bylaw repeals and replaces Bylaw No. 454 cited as the "Regional District of Central Okanagan Economic Development Commission Bylaw No. 454, 1991".
9. This bylaw may be cited as the "Regional District of Central Okanagan Economic Development Commission Bylaw No. 490, 1991".

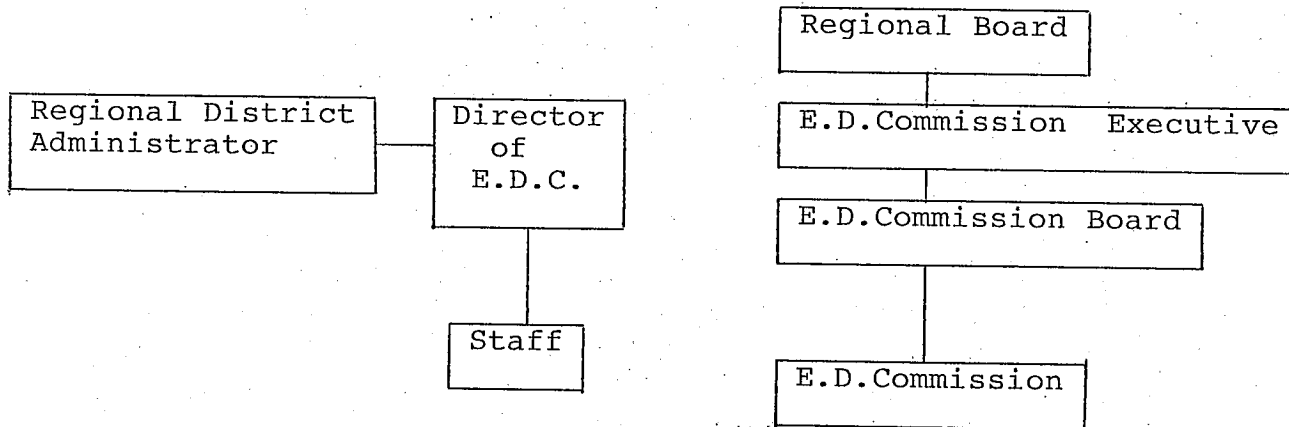
