BYLAW NO. 504

---

Being a bylaw to amend Bylaw No. 131

---

WHEREAS Bylaw No. 131 cited as the Regional District of Central Okanagan Municipal Employees Disclosure Bylaw designates certain employees as "Municipal Employees" under the "Public Officials and Employees Disclosure Act";

AND WHEREAS it is deemed necessary to amend Bylaw No. 131;

NOW THEREFORE The Regional Board of the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. That Bylaw No. 131 cited as the "Regional District of Central Okanagan Municipal Employees Disclosure Bylaw" is hereby amended as follows:

i) By deleting Clause #1 and replacing it with the following:

1. The following persons are hereby designated "Municipal Employees" by the Regional Board of the Regional District of Central Okanagan pursuant to the "Public Officials and Employees Disclosure Act":

- (a) A.T. Harrison, Administrator
- (b) H.E. Reay, Treasurer
- (c) H.J. Hettinga, Deputy Administrator
- (d) K.W.J. Arcuri, Director of Planning
- (e) K.J. Roth, Chief Building Inspector
- (f) W. Hoffman, Deputy Chief Building Inspector
- (g) W. Vos, Parks Superintendent
- (h) K.E. Danchuk, Economic Development Officer
- (i) G.A. Leier, Personnel Officer

2. This Bylaw repeals Bylaw No. 198, cited as the "Regional District of Central Okanagan Municipal Employees Disclosure Amendment Bylaw No. 198, 1980".


