

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 509

Being a bylaw to convert a sewer specified area to a local service area and to provide for the extension of the boundaries.

WHEREAS under Section 767(4) of the Municipal Act, a Regional District exercising a power to provide a service other than a general service is required to adopt a bylaw respecting that service which:

- a) meets the requirements of Section 794 for an establishing bylaw, and
- b) is adopted in accordance with the requirement of Section 802 as if it were a bylaw amending an establishing bylaw

AND WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 320, 1987, cited as the "Westbank Sewer Specified Area No. 1 Establishment and Loan Authorization Bylaw #320, 1987", as amended by Bylaw No. 332, 1987 and Bylaw No. 372, 1988, a specified area for the provision of sewer within a portion of Electoral Area 'H';

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to convert the aforesaid specified area to a local service;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to extend the boundaries of the local service area to include a portion of Electoral Area "G" and to increase the portion of Electoral Area "H".

AND WHEREAS the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 16, Subsection 4 of the Waste Management Act.

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. The sewer specified area created under Bylaw 320, cited as the "Westbank Sewer Specified Area No. 1 Establishment and Loan Authorization Bylaw #320, 1987", as amended by Bylaw No. 332, 1987 and Bylaw No. 372, 1988, is hereby established as a local service to be known as the "Westbank Sewer Local Service Area No. 1".
2. The participants in the local service, established under Section 1, are portions of Electoral Areas "G" and "H" as shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Section 809.1 to be collected by a parcel tax to be imposed in the manner provided by Section 810.1(2).
 - b) The imposition of fees and other charges that may be fixed by a separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 804(1)(b) for costs of the service shall be \$120,000.

5. This Bylaw may be cited as the "Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509 1992.






