

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 536

Being a bylaw to establish a local service within a portion of Electoral Area "H" to provide for the operation and maintenance of streetlighting.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act:

AND WHEREAS the Regional Board of the Regional District of Central Okanagan has been requested to establish a local service for the purpose of providing streetlighting for a portion of Electoral Area "H":

AND WHEREAS the Regional Board has received a sufficient petition under Section 801 of the Municipal Act requesting the establishment of the local service for streetlighting and has waived the assent requirement:

AND WHEREAS the Director of Electoral Area "H" has consented, in writing, to the adoption of this Bylaw:


NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:


1. The Regional District of Central Okanagan hereby establishes within Electoral Area "H" a local service for the purpose of providing streetlighting within the boundaries of the service area shown outlined on the plan attached as Schedule "A" to this bylaw and commonly known as "Mission Ridge Streetlighting Local Service Area".
2. The costs of providing the service shall be recovered by:
 - a) the requisition of money under Section 809.1 to be collected by a property value tax to be levied and collected under Section 810.1 (1).
 - b) the requisition of money under Section 809.1 to be collected by a parcel tax to be imposed in the manner provided by Section 810.1 (2).
3. The maximum amount that may be requisitioned annually under Section 804 (1) (a) and (b) for the service provided under Section 1 of this Bylaw shall not exceed the greater of:
 - a) \$3650.00
 - b) \$0.230 per \$1000.00 of net taxable value of land and improvements within the service area.
4. This Bylaw may be cited as the "Regional District of Central Okanagan Mission Ridge Streetlighting Local Service Area Establishment Bylaw No. 536 , 1992 .




