

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 537

Being a bylaw to amend a Local Service Area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established and expanded by Bylaw No. 422, 1990 cited as the "Westbank Streetlight Local Service Area Establishment and Expansion Bylaw No. 422, 1990", as amended by Bylaw No. 491, a local service area for the provision of the operation and maintenance of streetlighting within a portion of Electoral area "H".

AND WHEREAS it is deemed necessary to further amend the said Local Service Area to include Lot 1, Plan 40370, DL 3478, ODYD;

AND WHEREAS as a sufficient petition has been received by the Regional District of Central Okanagan for those lands to be added to the Westbank Streetlight Local Service Area;

AND WHEREAS the director of Electoral Area "H" has consented in writing to adoption of this bylaw.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Streetlighting Local Service Area created under Bylaw No. 422, cited as "The Westbank Streetlight Local Service Area Establishment and Expansion Bylaw No. 422, 1990", as amended by Bylaw No. 491, are hereby extended to include Lot 1, Plan 40370, DL 3478 ODYD.
2. Schedules 'A' and 'B' of Bylaw No. 422 and Schedule 'C' of Bylaw 491 are hereby deleted in their entirety and replaced with Schedule "A" attached hereto.
3. This bylaw may be cited as "The Regional District of Central Okanagan Westbank Streetlight Local Service Area Amending Bylaw No. 537, 1992".


