

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 542

Being a bylaw to amend the Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990 on the 5th day of March, 1990, for the purpose of providing fire protection within a portion of Electoral Area "I";

AND WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Ellison Fire Protection Local Service Amending Bylaw No. 503, 1992 for the purpose of amending the boundaries of the local service area on the 31st day of August, 1992.

AND WHEREAS the aforesaid Bylaw No. 418, 1990 provides that the annual operating costs and debt servicing costs be recovered by requisition of monies to be collected by a property value tax levied on improvements only for Regional Hospital purposes within the local service area;

AND WHEREAS it is deemed necessary to amend the said Bylaw so that the annual operating costs and debt servicing costs be recovered by requisition of monies to be collected by a property value tax levied on land and improvements for Regional Hospital purposes within the service area so as to provide sufficient funds for the operation of the said Fire Department;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN, in open meeting assembled enacts as follows:

1. That the Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990 be amended as follows:
 - Clause 3 is hereby repealed and replaced by the following wording,
 3. "the annual operating costs and debt servicing costs shall be recovered by requisition of monies to be collected by a property value tax levied on land and improvements for Regional Hospital purposes within the service area".
2. This Bylaw may be cited as the "Regional District of Central Okanagan Ellison Fire Protection Local Service Establishment Amendment Bylaw No. 542, 1992.
