

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 549

Being a bylaw to convert a function to a local service for the purpose of providing Westside Community Parks.

WHEREAS the Regional Board of the Regional District of Central Okanagan may by bylaw establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Lieutenant-Governor In Council of the Province of British Columbia by Supplementary Letters Patent dated the 31st day of July, 1973, and amended by Supplementary Letters Patent dated May 13, 1976, October 25, 1979, June 4, 1981, July 14, 1982, and March 31, 1989, granted the power to the Regional District of Central Okanagan to acquire, develop, operate and maintain Community Parks with the Electoral Areas of A, G, H and I, as participating areas in this service;

AND WHEREAS the Regional District of Central Okanagan wishes to convert the aforesaid function to a local service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. Service Being Established

The Community Parks Function created by the issuance of Supplementary Letters Patent dated the 31st day of July, 1973 is hereby established as a local service.

2. Service Area Boundaries

- (a) The boundaries of the local service area shall comprise Electoral Area G and Electoral Area H.
- (b) The local service area so defined shall be known as Westside Community Parks Local Service Area.

3. Participating Areas

The participating areas for the local service is Electoral Area G and Electoral Area H.

4. Cost Recovery

As provided for in Section 804(1) of the Municipal Act, the annual costs of providing the service shall be recovered by the requisition of money under Section 809.1 to be collected by a property value tax to be levied and collected under Section 810.1.

5. Requisition Limit

The maximum amount of money that may be requisitioned annually under Section 804(1) of the Municipal Act for the service provided under Section 1, shall not exceed \$0.37 per \$1,000 of net taxable value of land and improvements for Regional Hospital purposes, within the local service area.

6. This bylaw may be cited as the "Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549 , 1993."
