BYLAW NO. 551

Being a bylaw to amend the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435, 1990".

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435, 1990, as amended by Bylaw No. 455 and 465;

AND WHEREAS it is deemed necessary to amend the said Ticket Information Utilization Bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

 4. This Bylaw may be cited for all purposes as "Regional District of Central Okanagan Ticket Information Utilization Amendment Bylaw No. 551, 1993".
