

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 581

---

Being a bylaw to provide for the imposition of a user fee against the owner or occupier of real property for the collection of garbage.

---

WHEREAS the Solid Waste Management Plan for the Regional District of Central Okanagan recommends universal residential user pay garbage collection;

AND WHEREAS the Regional District of Central Okanagan Solid Waste Management Local Service Area Establishment Bylaw No. 577 provides for the collection of garbage;

AND WHEREAS it is necessary to impose user fees for the collection of garbage;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:


1. There is hereby imposed and levied a garbage collection user charge against the owner or occupier of land or real property whose property is required to utilize the garbage collection system and the Treasurer shall classify each consumer in accordance with the categories set out in Schedule "A", attached to and forming part of this Bylaw.
2. The rate shall be due and payable on the last business day of each billing month.
3. In the case of a collection commencing during any year, the charge imposed shall begin with the month during which the collection commenced. If made on or before the 15th day of the month, the full monthly rate shall be charged, otherwise the charge shall be one-half of the monthly charge.
4. Any rate remaining unpaid on the thirty-first of December shall be deemed to be taxes in arrears in respect of the property on which the consumer dwells and shall be forthwith entered on the real property tax roll by the Collector as taxes in arrears.
5. This bylaw may be cited as the "Regional District of Central Okanagan Garbage Collection User Rates Bylaw No. 581 , 1993.







SCHEDULE 'A'

GARBAGE COLLECTION RATES

The following rates and penalties shall be paid for the removal of garbage under the terms of this bylaw:

1. Residential Dwelling Premises

- (a) Effective January 1, 1994 - \$40.00 per year per individual dwelling premise for basic service.
- (b) Effective January 1, 1994 - \$1.50 per tag.

2. General Regulations

- (a) Any payment received shall be applied first to arrears, then to current charges.
  - (b) Residential dwelling premises will be invoiced semi-annually.
  - (c) A \$10 service charge will be applied to NSF cheques.
