

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 583

Being a bylaw to amend the boundaries of a Streetlighting Local Service Area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established and expanded by Bylaw No. 496, 1992 cited as the "Regional District of Central Okanagan Shannon Lake Estates Ornamental Streetlighting And Street Name Signs Local Service Area Establishment and Expansion Bylaw No. 496, 1992, a service area for the provision of the operation and maintenance of streetlighting within a portion of Electoral Area "H".

AND WHEREAS it is deemed necessary to further amend the said Local Service Area to include Lot 3 Plan 23091, DL 2602 ODYD, and that part of DL 2602 ODYD, except Plans 23091, 38566, 39546 and 40234.

AND WHEREAS as a sufficient petition has been received by the Regional District of Central Okanagan for those lands to be added to the Shannon Lake Estates Ornamental Streetlighting and Street Name Signs Local Service Area.

AND WHEREAS the director of Electoral Area "H" has consented in writing to adoption of this bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Streetlighting Local Service Area created under Bylaw No. 496, cited as the "Regional District of Central Okanagan Shannon Lake Estates Ornamental Streetlighting and Street Name Signs Local Service Area Establishment and Expansion Bylaw No. 496, 1992" are hereby extended to include Lot 3, Plan 23091, DL 2602 ODYD and that part of DL 2602 ODYD, except Plans 23091, 38566 39546 and 40234 as shown as the shaded area on Schedule 'A' attached hereto and forming part of the bylaw.
2. This bylaw may be cited as the "Regional District of Central Okanagan Shannon Lake Estates Ornamental Streetlighting and Street Name Signs Local Service Area Amending Bylaw No. 583, 1994.






