

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 613

Being a bylaw to amend the Regional District of Central Okanagan Emergency Program Bylaw No. 576, 1993.

Whereas the Regional Board of the Regional District of Central Okanagan on October 17, 1994 adopted Bylaw No. 576, cited as the Regional District of Central Okanagan Emergency Program Bylaw No. 576, 1993 for the purposes of establishing an Emergency Program.

AND WHEREAS the Council of the District of Peachland, by resolution adopted at their October 18, 1994 Regular Meeting, has requested that the Emergency Program Bylaw No. 576 be amended to include a District of Peachland Councillor on the Emergency Plan Executive Board;

NOW THEREFORE BE IT RESOLVED THAT THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN, in open meeting assembled, enacts as follows:

1. That Clause 4 of the Regional District of Central Okanagan Emergency Program Bylaw No. 576, 1993 be hereby amended to include representation of one Councillor of the District of Peachland on the Emergency Plan Executive Board so it reads as follows:
 4. There shall be established an Emergency Plan Executive Board consisting of the Chairperson of the Regional District, the Mayor of Kelowna, the Mayor of Peachland, one Regional District Electoral Area representative, one City of Kelowna Councillor and one District of Peachland Councillor; which shall be chaired by the Chairperson of the Regional District. In the absence of the Chairperson of the Regional District, the Mayor of the City of Kelowna shall act as Chairperson and in his/her absence, the Mayor of the District of Peachland.
2. This bylaw may be cited as the Regional District of Central Okanagan Emergency Program Amendment Bylaw No. 613, 1994.


