BYLAW NO. 632

Being a bylaw to amend the Regional District of Central Okanagan Garbage Collection User Rates.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Garbage Collection User Rates By-law No. 581, 1993, on December 13, 1993;

AND WHEREAS the Regional Board deems it advisable to amend the said bylaw;

NOW THEREFORE, The Regional Board of the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. Schedule 'A' of By-law No. 581 cited as "Regional District of Central Okanagan Garbage Collection User Rates By-law No. 581, 1993," is hereby amended by deleting said Schedule 'A' and replacing with Schedule 'A' attached hereto.
6. This bylaw may be cited as the "Regional District of Central Okanagan Garbage Collection User Rates Amendment By-law No. 632, 1995".



SCHEDULE 'A'

BYLAW 632

Attached to and forming part of Bylaw No. 632 cited as the "Regional District of Central Okanagan Garbage Collection User Rates Amendment By-law No. 632, 1995".

GARBAGE COLLECTION RATES

The following rates and penalties shall be paid for the removal of garbage under the terms of this bylaw:

1. Residential and Seasonal Dwelling Premises

- (a) Effective May 1, 1995 - \$40.00 per year per individual dwelling premise for basic service.
- (b) Effective May 1, 1995 - \$1.50 per tag.

2. General Regulations

- (a) Any payment received shall be applied first to arrears, then to current charges.
- (b) Residential and seasonal dwelling premises will be invoiced semi-annually.
- (c) A \$10 service charge will be applied to NSF cheques.
