

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 653

---

Being a bylaw to establish the extended service of health regulation to regulate persons, their premises and activities, in order to promote the preservation of the health of all inhabitants of the electoral areas of the Regional District of Central Okanagan.

---

WHEREAS the Regional District of Central Okanagan was granted the additional power of Health Regulation under Section 692(1)(a) of the Municipal Act, subject to the Health Act, with respect to regulating persons, their premises and activities, in order to promote the preservation of health in all electoral areas as an extended service by B.C. Regulation 494/94, Order in Council No. 1572, 1994.

AND WHEREAS, pursuant to Section 789(1)(f.3) of the Municipal Act, the Regional Board of the Regional District of Central Okanagan wishes to establish an extended service for the aforesaid purpose;

AND WHEREAS Electoral Areas 'G', 'H' and 'I' wish to participate in this service;

AND WHEREAS under Section 800(1)(b), the Board has waived the assent requirements of Section 795(2)(a)(i) by obtaining the written consent of the Electoral Area Directors representing Electoral Areas 'G', 'H' and 'I';

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional District of Central Okanagan hereby establishes the extended service of Health Regulation in all electoral areas under Section 692(1)(a) of the Municipal Act, to be known as the Health Regulation Service.
2. Electoral Areas 'G', 'H' and 'I' shall be the participating areas in this extended service.
3. The Regional District may enact and carry out or cause to carry out Health Regulations within the said service area or a portion thereof with its own resources or by entering into contractual agreements.
4. The costs for this service may be recovered by:
  - a. the requisition of money under Section 809 and 809.1 of the Municipal Act to be collected by a property value tax as provided in Section 810(1) and 810.1 of the Municipal Act.
  - b. the imposition of fees and charges that may be fixed by separate bylaw for the purpose of recovering the costs.
5. The cost of providing the services shall be apportioned among the participating areas on the basis of the converted values of land and improvements in those areas.
6. This Bylaw may be cited for all purposes as the "Regional District of Central Okanagan Health Regulation Extended Service Establishment Bylaw No. 653, 1995."

NOW THEREFORE BE IT RESOLVED THAT



Pursuant to the provisions of Section 800(2) of the Municipal Act, the Electoral Area Directors of Electoral Areas "G", "H" and "I" hereby consent on behalf of the electors of the said Electoral Areas to participate and share as an electoral participating area in the establishment of the extended service for health regulation.






