

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 655

---

Being a bylaw to establish and operate an extended service for business licensing and regulation.

---

WHEREAS Sections 789 and 790 of the Municipal Act provide for the establishment and operation of extended services within the Regional District of Central Okanagan;

AND WHEREAS, pursuant to Section 790 of the Municipal Act, the Lieutenant Governor in Council has granted to the Regional District the additional power, as an extended service, to make bylaws under Division (1) and (4) of Part II of the Municipal Act respecting licensing and regulating businesses;

AND WHEREAS, pursuant to the additional powers granted by the Lieutenant Governor, the Regional District of Central Okanagan wishes to establish an extended service for the licensing and regulation of businesses;

AND WHEREAS Electoral Areas G, H and I wish to participate in this service;

AND WHEREAS under Section 800 (1) (b), the Regional Board has waived the assent requirement of Section 795 (2) (a) (i) by obtaining the written consent of the Electoral Area Directors representing Electoral Areas G, H and I;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

- 1) The Regional District of Central Okanagan hereby establishes the extended service of licensing and regulating businesses.
- 2) Electoral Areas G, H and I shall be participating areas in this extended service.
- 3) The annual cost for this service shall be recovered by money collected from business license fees.
- 4) The Regional District of Central Okanagan may enact and enforce regulations pursuant to this service.
- 5) This bylaw may be cited for all purposes as the "Regional District of Central Okanagan Business License and Regulation Extended Service Establishment Bylaw No. 655."






