2. This bylaw may be cited as the "Regional District of Central Okanagan Landfill User Rates Amendment Bylaw No. 656, 1995."







**BYLAW NO. 656**

**SCHEDULE 'A'**

**LANDFILL GARBAGE DISPOSAL FEES**

---

Attached to and forming part of Bylaw No. 656 cited as the "Regional District of Central Okanagan Landfill User Rates Amendment Bylaw No. 656, 1995."

---

The following rates shall be charged for all garbage delivered to the Westside Sanitary Landfill:

**(a) GARBAGE**

- (i) \$50.00 per metric tonne as measured by weight on the scale provided at the disposal site by the Regional District; or
- (ii) Effective January 1, 1996, \$1.00 per standard garbage container as defined in the Regional District of Central Okanagan Solid Waste Management Regulation Bylaw No. 580.
- (iii) \$6.00 for loads of residential waste weighing 250 kg or less notwithstanding the \$1.00 charge as defined above.

**(b) DIVERTABLE WASTE**

- (i) \$25.00 per tonne as measured by weight on the scale provided at the disposal site by the Regional District; or
- (ii) Loads 250 kg or less minimum \$6.00.

**(c) MANDATORY RECYCLABLE MATERIALS IN GARBAGE**

- (i) Double the required Landfill Garbage Disposal Fee for all garbage containing mandatory recyclable material.

**(d) ESTIMATED WEIGHTS**

- (i) In the event that the scales provided are not operational, weight shall be as estimated by the employee of the Regional District at the Disposal Site for that purpose.

**(d) GENERAL REGULATIONS**

- i) A \$10 service charge will be applied to NSF cheques.
