

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 681

Being a bylaw to amend a Local Service Area within a portion of Electoral Areas 'G' and Electoral Area - Westbank to provide for construction of a sanitary sewer trunk main.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 510, 1992 cited as the "Regional District of Central Okanagan Westbank Sewer Local Service Area No. 2 Establishment Bylaw No. 510, 1992 a local service area for the provision of sewer works within a portion of Electoral Areas 'G' and Westbank;

AND WHEREAS it is deemed necessary and expedient for administration purposes to rename the Westbank Sewer Local Service Area No. 2 to the Sewer System Local Service Area 201 - Westbank;

AND WHEREAS it is deemed necessary to construct a sanitary sewer trunk main in order to provide sufficient capacity to service existing and future sewer flows from the local service area;

AND WHEREAS it is deemed necessary and expedient to amend said Bylaw No. 510 to increase the requisition amount from \$63,000 to \$78,000.

AND WHEREAS the Regional District of Central Okanagan has an approved Liquid Waste Management Plan;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 16, Subsection 10 of the Waste Management Act;

AND WHEREAS the Directors of Electoral Areas G and Electoral Area - Westbank have consented in writing to the adoption of this bylaw.

AND WHEREAS the Board of the Regional District of Central Okanagan wishes to provide owners of properties within the proposed Sewer System Local Service Area 201 - Westbank the opportunity to pay the total per parcel capital cost prior to preparation of the first annual requisition for the service;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional District of Central Okanagan Westbank Sewer Local Service Area No. 2 Establishment Bylaw No. 510, 1992 is hereby amended as follows:
 - i) by deleting the figures \$63,000 in Section 4 and substituting therefore the figures \$78,000.
 - ii) The Board may, by separate bylaw, provide that the parcel tax imposition under Section 810.1(2) may be commuted for payment in cash under the terms and conditions set under that bylaw.
2. The "Westbank Sewer Local Service Area No. 2" is hereby renamed the "Sewer System Local Service Area 201 - Westbank";
3. This Bylaw may be cited as the 'Regional District of Central Okanagan Sewer System Local Service Area 201 - Westbank Amending Bylaw No. 681, 1996.


