

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 695.

A bylaw to establish a local service within a portion of Electoral Area "G" to provide for the acquisition, operation and maintenance of a domestic water system in the Westshore Subdivision.

WHEREAS a regional district may, by bylaw, acquire, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of acquiring, operating and maintaining a domestic water system in a portion of Electoral Area "G";

AND WHEREAS in accordance with Section 795(2)(a)(i) of the Municipal Act, the Regional Board has submitted the proposal to establish the local service to the electors within the service area located within a portion of Electoral Area "G";

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area "G", a local service to provide for the acquisition, operation and maintenance of a domestic water system to be known as the Westshore Water System Local Service Area".
2. The participants in the local service, established under Section 1, are portions of Electoral Area "G" as shown outlined on Schedule "A" attached hereto and forming part of this Bylaw.
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The imposition of fees and other charges that may be fixed by a separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 804 (1) for costs of the service shall be nil.
5. This bylaw may be cited as "Regional District of Central Okanagan Westshore Water System Local Service Area Establishment Bylaw No. 695 , 1996".


