

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 699

Being a bylaw to provide for the commuting of parcel taxes to provide for the removal of stagnant water within the Regional District of Central Okanagan Water Distribution Local Service Area - Green Bay.

WHEREAS a local service for the purpose of removing stagnant water has been established by the Regional District of Central Okanagan by Bylaw No. 687, cited as the "Regional District of Central Okanagan Water Distribution Local Service Area - Green Bay Establishment Bylaw No. 687, 1996;

AND WHEREAS Bylaw No. 687 specifies that the annual cost of providing this service shall be recovered by the requisition of money under Section 809.1 of the Municipal Act, to be collected by a parcel tax to be imposed in the manner provided by Section 810.1 (2) and the imposition of fees and other charges;

AND WHEREAS Bylaw No. 687 further specifies that the Regional Board of the Regional District of Central Okanagan may by separate bylaw provide that the parcel tax imposition under Section 810.1 (2) may be commuted for payment in cash under the terms and conditions of that Bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1) That the parcel tax imposed under Section 810.1 (2) of the Municipal Act, as enacted by the Regional District of Central Okanagan Water Distribution Local Service Area - Green Bay Establishment Bylaw No. 687, may be commuted for payment in cash pursuant to Section 810.1 (2.1) under the following terms and conditions:

Any person, whose parcel is subject to being specifically charged a parcel tax pursuant to Bylaw No. 687 of the Regional District of Central Okanagan, may commute the parcel tax imposed thereon, by making a one time payment in cash equal to the portion of the cost of providing for the removal of stagnant water assessed upon the parcel within forty five days of receipt of written instructions from the Regional District of Central Okanagan.


- 2) This Bylaw may be cited as the "Regional District of Central Okanagan Green Bay Water Distribution Parcel Tax Commutation Bylaw No. 699 , 1996.
