Being a bylaw to provide for the remuneration and expenses of Directors and Committee Members.

---

WHEREAS the provisions of Section 780 of the Municipal Act provides for the remuneration and expenses of Directors and Committee Members.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

Monthly Remuneration

1. THAT all Municipal Directors, except the Chairperson, shall receive a bi-weekly remuneration of Four Hundred and Sixty-One Dollars and Fifty-four cents (\$461.54). <sup>489.81</sup>
2. THAT all Electoral Area Directors shall receive a bi-weekly remuneration of Six Hundred Dollars (\$600.00). <sup>636.74</sup>
3. THAT the Chairperson shall receive a bi-weekly remuneration of One Thousand Three Hundred and Thirty-Eight Dollars and Fourty-six cents (\$1,338.46). <sup>1420.41</sup>
4. Alternate directors are entitled to receive remuneration of seventy-nine dollars (\$79.00) for each Regional Board meeting attended. <sup>83.85</sup>

Remuneration For Attending Meetings

5. All elected officials of the Regional District of Central Okanagan, City of Kelowna, District of Peachland, and the District of Lake Country, when those persons are serving in their capacity as a committee member at a duly constituted committee meeting of the Regional District of Central Okanagan, are entitled to receive:
  - a) fifty-three dollars <sup>56.25</sup> (\$53.00) for each half day regularly constituted committee meeting attended and one hundred and five dollars <sup>111.43</sup> (\$105.00) for each full day regularly constituted committee meeting attended.
  - b) reasonable expenses incurred by him/her for attending meetings of the Regional Board, committee meetings and engaging in the business of the Regional District specifically authorized by the Board together with the mileage for the use of their privately owned automobiles at the following rates:
    - i) ~~41.32~~ cents per km for cars and light pickup trucks.
    - ii) ~~41.35~~ cents per km for four wheel drive and heavy duty pickup trucks.
6. All Directors and Alternate Directors, including the Chairperson, are entitled to receive remuneration and expenses as outlined in 5(a) and 5(b), for attendance at other meetings specifically authorized by the Board, but shall not receive remuneration for attendance at Union of British Columbia Municipalities or Okanagan Mainline Municipal Association conventions.

- 7. For the calendar year 1998, the remuneration set out in Paragraphs 1-5(a) inclusive, shall be increased or decreased by a percentage amount equal to the percentage increase or decrease in the official Consumer Price Index for Vancouver (all items) for the year 1997 published by Statistics Canada. In each subsequent calendar year thereafter, the annual remuneration for the immediately preceding year shall be increased or decreased by a percentage amount equal to the percentage increase or decrease in the official Consumer Price Index for Vancouver (all items) for the immediately preceding year published by Statistics Canada.

General

- 8. Of the remuneration provided under paragraphs 1 - 5(a) inclusive, one-third shall be an allowance for expenses incidental to the duties of office.




