

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 722

---

Being a bylaw to amend the cost apportionment formula for transit service for Peachland and Electoral Areas Westbank and 'G'.

---

WHEREAS Bylaw No. 376 cited as "Regional District of Central Okanagan Urban Transit Local Service Establishment Bylaw No. 376, 1990" was adopted January 22, 1990;

AND WHEREAS it is deemed necessary to amend the cost apportionment formula to reflect a change in service to the Corporation of the District of Peachland;

AND WHEREAS the Council of the Corporation of the District of Peachland and the Electoral Area Directors for Electoral Areas Westbank and 'G' have consented to this bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. The first paragraph 5 of the enactment portion of "Regional District of Central Okanagan Urban Transit Local Service Establishment Bylaw No. 376, 1990" is hereby deleted in its entirety and the following substituted therefore:
  5. The annual operating costs and debt servicing shall be recovered as follows:
    - a) by a requisition to the Corporation of the District of Peachland in the amount of 15% of the annual requisition as set forth in the current annual budget;
    - b) by a requisition of monies to be collected by a property value tax on land and improvements within Electoral Area Westbank and the defined portion of Electoral Area 'G' exclusive of amounts raised in 5 (a) above.
2. The second paragraph 5 of the enactment portion of "Regional District of Central Okanagan Urban Transit Local Service Establishment Bylaw No. 376, 1990" is renumbered "6".
3. This bylaw may be cited as "Regional District of Central Okanagan Urban Transit Local Service Establishment Amendment Bylaw No. 722, 1997".


