BYLAW NO. 725

Being a bylaw to amend the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435, 1990.

WHEREAS the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435, 1990 and amendments thereto;

AND WHEREAS it is deemed necessary to amend the said Ticket Information Utilization Bylaw;

NOW THEREFORE the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. Article 3 of Bylaw 435 is amended by deleting the words "Schedules 2 through 10, 1994" and replacing them with the words "Schedules 2 through 12".
2. Article 4 of Bylaw No. 435 is amended by deleting the words "Schedules 2 through 10, 1994" and replacing them with the words "Schedules 2 through 12".
3. Schedule 1, 1994 of Bylaw No. 435 shall be deleted in its entirety and replaced with a new Schedule 1, attached hereto and forming part of this bylaw.
4. Schedule 4, 1994 of Bylaw No. 435 shall be deleted in its entirety and replaced with a new Schedule 4, attached hereto and forming part of this bylaw.
5. Schedules 11 and 12 shall be added to this bylaw as Schedule 11 and 12 attached hereto and forming part of this bylaw.
6. This bylaw may be cited for all purposes as Regional District of Central Okanagan Ticket Information Utilization Amendment Bylaw No. 725, 1997".


