REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 726

A bylaw to establish a local service within a portion of Electoral Area - Westbank to provide for the acquisition, operation and maintenance of a domestic water system in the Pritchard Drive area.

WHEREAS a regional district may, by bylaw, acquire, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of acquiring, operating and maintaining a domestic water system in a portion of Electoral Area - Westbank;

AND WHEREAS in accordance with Section 795(2)(a)(i) of the Municipal Act, the Regional Board has received assent under Section 801, a sufficient petition for the service;

AND WHEREAS the Director of Area - Westbank has consented, in writing, to the adoption of this Bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1. The Regional District hereby establishes within Electoral Area Westbank, a local service to provide for the acquisition, operation and maintenance of a domestic water system to be known as the "Pritchard Water System Local Service Area".
- 2. The participants in the local service, established under Section l, are portions of Electoral Area Westbank as shown outlined on Schedule "A" attached hereto and forming part of this Bylaw.
- 3. The annual costs for the service established in Section l shall be recovered by:
 - a) The imposition of fees and other charges that may be fixed by a separate bylaw for the purpose of recovering these costs.
- 4. The maximum amount that may be requisitioned annually under Section 804 (1) for costs of the service shall be nil.
- 5. This Bylaw may be cited as the "Regional District of Central Okanagan Pritchard Water System Local Service Area Establishment Bylaw No. 726, 1997".


