

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 729

Being a bylaw to amend the Regional District of Central Okanagan (Area 302 - Mount Boucherie) Temporary Borrowing Bylaw No. 643, 1995.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the "Regional District of Central Okanagan (Area 302 - Mount Boucherie) Temporary Borrowing Bylaw No. 643, 1995" to provide for the temporary borrowing upon the credit of the Regional District of Central Okanagan the sum of Eight Hundred and Twenty Thousand Dollars (\$820,000) for the estimated cost of constructing a sewer system, including expenses thereto;

AND WHEREAS it has been found subsequent to the enactment of Bylaw No. 643 that the total cost of constructing the said sewer works will be One Million, Two Hundred Thousand Dollars (\$1,200,000);

AND WHEREAS it is deemed necessary and expedient to amend said Bylaw No. 643 to increase the amount to be temporarily borrowed upon the credit of the Regional District of Central Okanagan from \$820,000 to \$1,200,000;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:


1. The "Regional District of Central Okanagan (Area 302 - Mount Boucherie) Temporary Borrowing Bylaw No. 643, 1995" is hereby amended as follows:
  - a) By deleting the words and numbers "Eight Hundred and Twenty Thousand Dollars (\$820,000)" in the second paragraph of the Bylaw preamble and substituting the words and numbers "One Million, Two Hundred Thousand Dollars (\$1,200,000)".
  - b) By deleting the words and numbers "Eight Hundred and Twenty Thousand Dollars (\$820,000)" in Section 1 and substituting the words and numbers "One Million, Two Hundred Thousand Dollars (\$1,200,000)".
2. This Bylaw may be cited as the "Regional District of Central Okanagan (Area 302 - Mount Boucherie) Temporary Borrowing Amending Bylaw No. 729, 1997".


