BYLAW NO. 734

Being a bylaw to amend the Water Utility User and Maintenance Fee Bylaw.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the "Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw No. 664, 1996", as amended by Bylaw No. 709;

AND WHEREAS, subsequent to the adoption of Bylaw No. 709, the Regional Board adopted the "Regional District of Central Okanagan Pritchard Water System Local Service Area Establishment Bylaw No. 726, 1997" to provide for the acquisition, operation and maintenance of a domestic water system in the Pritchard Drive area;

AND WHEREAS the Regional Board deems it necessary and expedient to amend Bylaw No.709 to include the Pritchard Water System Local Service Area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. Schedule 'A' of Bylaw No.709 cited as the "Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw No. 709, 1997" is hereby amended by deleting said Schedule 'A' in its entirety and replacing with Schedule 'A' attached hereto;
2. This Bylaw may be cited as the "Regional District of Central Okanagan Water Utility User and Maintenance Fee Amending Bylaw No. 734, 1997".
