

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 742

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 509 cited as the "Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509, 1992" as amended by Bylaw No. 540, 1992 a local service area for the purpose of providing sewer service to a portion of Electoral Areas 'G' and 'Westbank' and Bylaw No. 723, 1997 to include the Corporation of the District of Peachland;

AND WHEREAS the Council of the Corporation of the District of Peachland and the Area Directors of Electoral Areas 'G' and 'Westbank' have consented in writing to the adoption of Bylaw No. 723 to include the District of Peachland in the local service area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509, 1992 as amended by No. 540, 1992 and No. 723, 1997 is hereby amended as follows:

By deleting Section 2 of Bylaw No. 509 and substituting the following:

2. The participants in the local service, established under Section 1, are portions of Electoral Areas 'G', 'Westbank' and the 'District of Peachland' as shown outlined on Schedules 'A' and 'B' which form part of Bylaw No. 723.
3. This bylaw may be cited as "Regional District of Central Okanagan Westside Regional Sewer System Amendment Bylaw No. 742, 1997."


