

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 753

A bylaw to establish a local service within a portion of Electoral Area 'G' and a portion of Electoral Area - Westbank, to provide recreation services and activities for youth.

WHEREAS a Regional District may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service in a portion of Electoral Area 'G' and a portion of Electoral Area - Westbank, for the purpose of providing recreation services and activities for youth;

AND WHEREAS, in accordance with Section 807(2)(b) of the Municipal Act, the Regional Board has received assent under Section 808;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. Service being established

- (a) The service being established under this bylaw is the local service of recreation, pursuant to section 798(1)(f) of the Municipal Act.
- (b) The local service of recreation being established under Section 1(a) is for the purpose of providing recreation services and activities for youth.

2. Service Area Boundaries

- (a) The boundaries of the service area shall comprise that portion of Electoral Area 'G' outlined in Schedule 'A', and that portion of Electoral Area - Westbank outlined in Schedule 'B', attached to and forming part of this bylaw.
- (b) The service area so defined shall be known as the "Westside Recreation Services and Activities for Youth Local Service Area".

3. Participating Areas

The participating area for the service is that portion of Electoral Area 'G' outlined in Schedule 'A' and that portion of Electoral Area - Westbank outlined in Schedule 'B', attached to and forming part of this bylaw.

4. Cost Recovery

In accordance with Section 816(1) of the *Municipal Act*, the annual costs of providing the service shall be recovered by:

- (a) the requisition of money under section 823 to be collected by a property value tax to be levied and collected under section 825, and
- (b) the imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs.

5. Requisition Limit

The maximum amount of money that may be requisitioned annually under section 816(1)(b) of the *Municipal Act* for the service provided under Section 1 of this bylaw, shall not exceed \$ 0.11 per \$1,000 of net taxable value of land and improvements for Regional Hospital purposes, within the service area.

6. Citation

This bylaw may be cited as "Regional District of Central Okanagan Westside Recreation Services and Activities for Youth Local Service Area Establishment Bylaw No. 753, 1997".





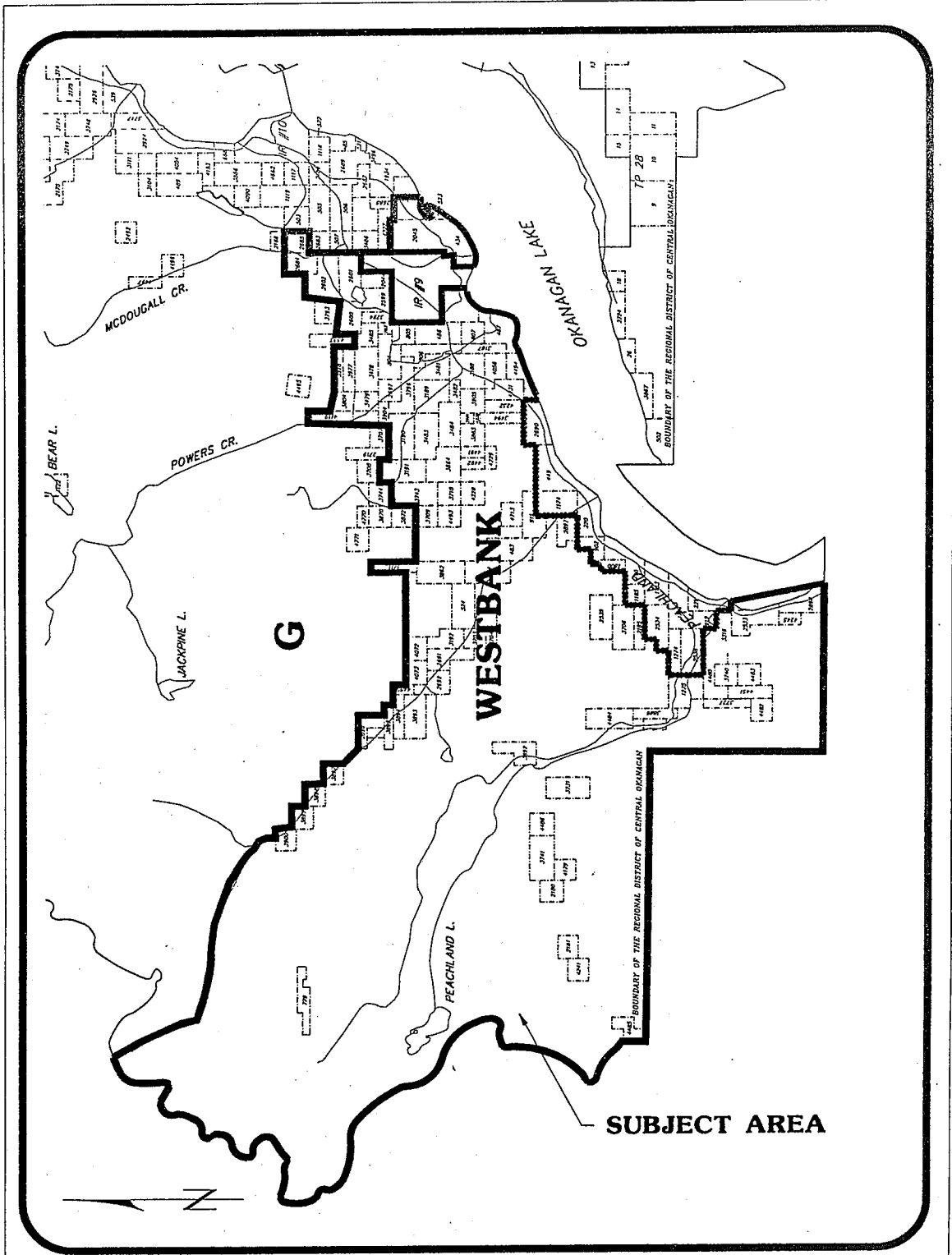

SCHEDULE 'A' - DEFINED AREA OF ELECTORAL AREA - WESTBANK

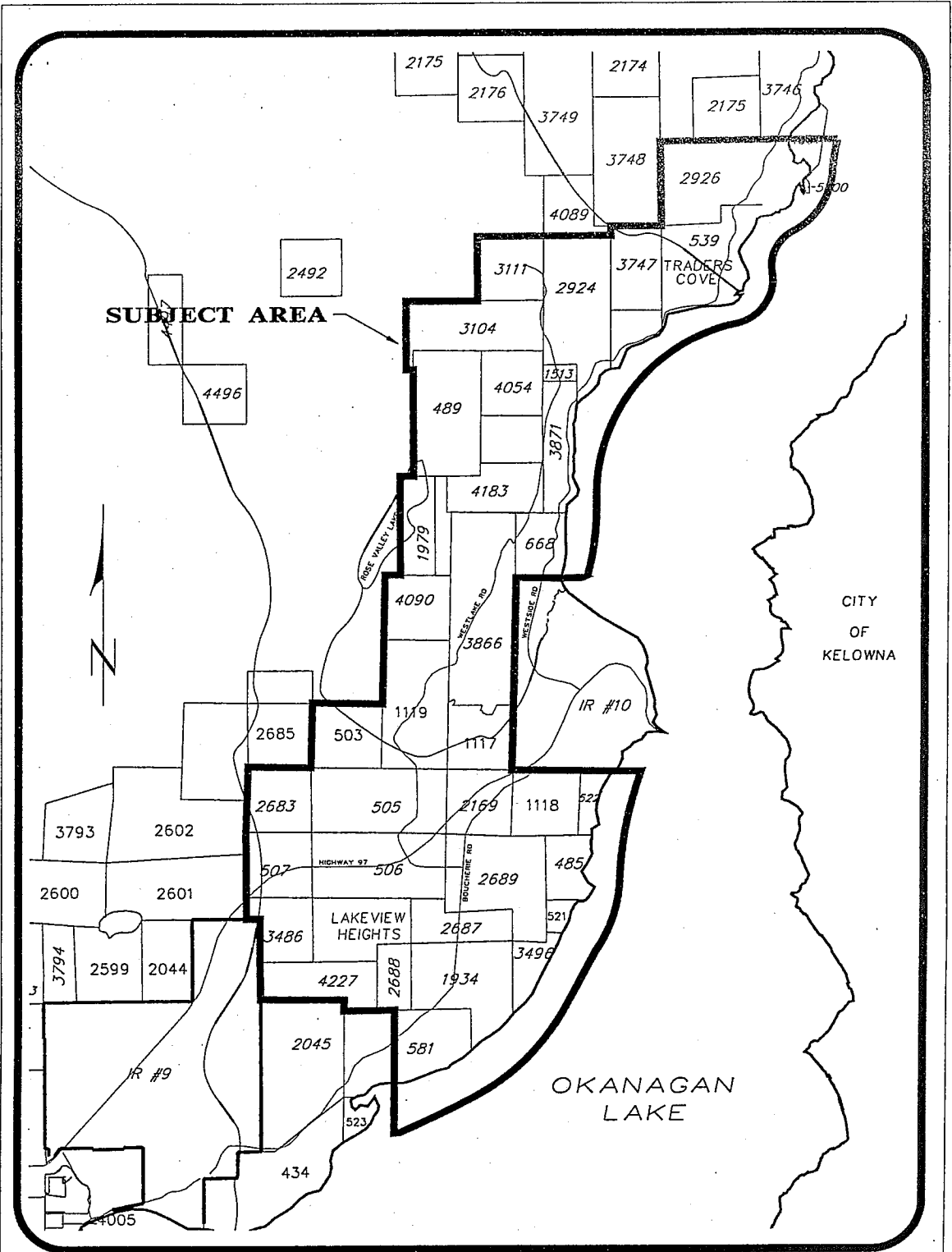
