BYLAW NO. 758

Being a bylaw to amend the Regional District of Central Okanagan Solid Waste Management Regulation Bylaw No. 580.

WHEREAS the Regional Board adopted the Regional District of Central Okanagan Solid Waste Management Regulation Bylaw No. 580, 1993;

AND WHEREAS it is deemed necessary to amend said bylaw;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. Amend Section 1.0 as follows:
 - a) Delete definition of "Garbage Collection Area" and replace with a new definition: "Garbage Collection Area" means Electoral Areas G, Westbank and I, excluding areas falling within the boundaries of the City of Kelowna, the District of Peachland, the District of Lake Country or Indian Reserve Lands.
 - b) In the definition of "Mandatory Recyclable Material", delete the words, "for recycling" and replace them with, "and must be recycled instead of landfilled".
 - c) In the definition of "Residential Dwelling Premise", delete the words, "and units in a mobile home park".
 - d) In the definition of "Tag-a-Bag Tie", delete all of the words "Tie" and replace them with the word "Tag".
2. Delete Section 6.1 and replace with:


No person shall place or mix, with any material for removal as garbage any Prohibited Materials, including but not limited to, any explosive, volatile, corrosive materials or dangerous chemicals.
3. Schedule "A" of Bylaw 580, 1993, cited as the Regional District of Central Okanagan Solid Waste Management Regulation Bylaw No. 580, 1993" is hereby deleted in its entirety and replace with "Schedule A, 1997" attached hereto.
4. This bylaw may be cited as the "Regional District of Central Okanagan Solid Waste Management Regulation Amendment Bylaw No. 758, 1997."

SCHEDULE "A", 1997

BYLAW NO. 758

GARBAGE PICK UP LIMITS

The following amounts of garbage may be placed for pick up from residential dwelling premises:

2 bags/190 litres maximum per dwelling unit* per pick-up

- * A maximum of two additional bags (190 litres) will be picked up provided these bags are tagged with a "Tag-a-Bag" tag. Users of the "Tag-a-Bag" tag shall pay the fees set out in the Regional District of Central Okanagan Garbage Collection User Rates Bylaw No. 581, 1993.
