

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 793

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No.726 cited as the "Regional District of Central Okanagan Pritchard Water System Local Service Area Establishment Bylaw No. 726, 1997" a local service area for the purpose of providing water service to a portion of Electoral Area 'Westbank'.

AND WHEREAS the Regional Board deems it necessary to amend the said local service area to include:

Lot 1, Plan 2685, DL 434 ODYD
Lot A, Plan 32445, DL 434 ODYD

AND WHEREAS in accordance with Section 807(2)(I) of the Municipal Act, the Regional Board has received assent under Section 812, a sufficient petition for the service;

AND WHEREAS the Director of Electoral Area 'Westbank' has consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Local Service Area created under Bylaw No. 726 cited as the "Regional District of Central Okanagan Pritchard Water System Local Service Area Establishment Bylaw No. 726, 1997 are hereby extended to include Lot 1, Plan 2685, DL 434 ODYD and Lot A, Plan 32445, DL 434 ODYD shown as the shaded area on Schedule 'A' attached hereto and forming part of the Bylaw.
2. This bylaw may be cited as the "Regional District of Central Okanagan Pritchard Water System Local Service Area Amending Bylaw No. 793, 1998".

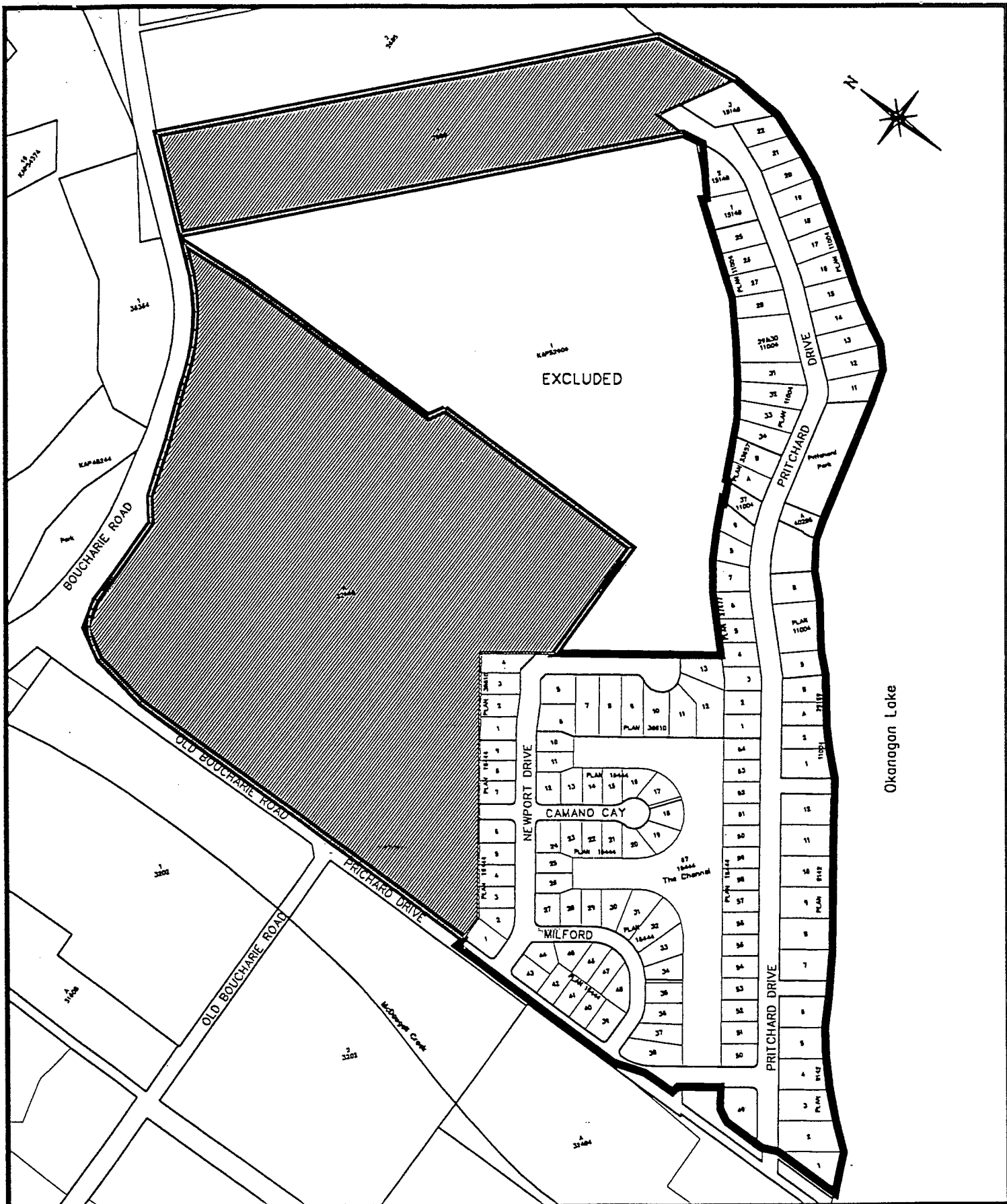


