

# REGIONAL DISTRICT OF CENTRAL OKANAGAN

## BYLAW NO. 797

---

Being a bylaw to amend the Regional District of Central Okanagan Sewer System Local Service Area 304 - Mount Boucherie Loan Authorization Bylaw No. 728, 1997.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Sewer System Local Service Area 304 - Mount Boucherie Loan Authorization Bylaw No. 728, 1997" to provide for the borrowing upon the credit of the Regional District of Central Okanagan the sum of One Hundred and Forty Thousand Dollars (\$140,000) for the estimated cost of constructing a sewer system, including expenses thereto;

AND WHEREAS it has been found subsequent to the enactment of Bylaw No. 728 that the total cost of constructing the said sewer works is One Hundred and Seventy Five Thousand Dollars (\$175,000);

AND WHEREAS it is deemed necessary and expedient to amend said Bylaw No. 728 to increase the amount to be borrowed upon the credit of the Regional District of Central Okanagan from \$140,000 to \$175,000;

AND WHEREAS the Minister of Municipal Affairs and Housing has approved the adoption of this bylaw;

AND WHEREAS the Director of Area 'G' has consented to the establishment of the local service area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The "Regional District of Central Okanagan Sewer System Local Service Area 304 - Mount Boucherie Loan Authorization Bylaw No. 728, 1997" is hereby amended as follows:
  - a) By deleting the words and numbers "One Hundred and Forty Thousand Dollars (\$140,000)" in the Bylaw Title Clause and substituting the words and numbers "One Hundred and Seventy Five Thousand Dollars (\$175,000)".
  - b) By deleting the words and numbers "One Hundred and Forty Thousand Dollars (\$140,000)" in Subsection (a) of Section 1 and substituting the words and numbers "One Hundred and Seventy Five Thousand Dollars (\$175,000)".




