BYLAW NO. 798

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 418 cited as the "Regional District of Central Okanagan Ellison Fire Protection Local Service Area Establishment Bylaw No. 418, 1990" as amended, a local service for the purpose of providing fire protection to a portion of Electoral Area 'I';

AND WHEREAS the Regional Board deems it necessary to expand the said local service area to include :

Lot 1, Plan 40541
Lot A, Plan 40540
Lot A, Plan 47885

AND WHEREAS pursuant to Section 812 of the Municipal Act, the Regional District of Central Okanagan has obtained a valid petition for the service;

AND WHEREAS the Director of Electoral Area 'I' has consented in writing to the adoption of this Bylaw;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Ellison Fire Protection Local Service Area Establishment Bylaw No. 418, 1990, as amended, are hereby further amended to include Lot 1, Plan 40541; Lot A, Plan 40540; Lot A, Plan 47885 ODYD, shown as the shaded area on Schedule 'A' attached hereto and forming part of the Bylaw.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Ellison Fire Protection Local Service Area Amendment Bylaw No. 798 , 1998.
