

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 801

A bylaw to establish a local service within a portion of Electoral Areas 'G' and 'Westbank' to provide for sewer service, which includes design, construction, and operation of a sanitary sewer collection system, force main, and lift station, to the Sunnyside and Sunnyview areas.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, force main, and lift station, to a portion of Electoral Areas 'G' and 'Westbank';

AND WHEREAS the Regional District of Central Okanagan has an approved Liquid Waste Management Plan;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 18, Subsection (9) of the Waste Management Act;

AND WHEREAS the Directors of Electoral Areas 'G' and 'Westbank' have consented to the establishment of the local service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Areas 'G' and 'Westbank' a local service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, force main, and lift station, and to be known as the "Sewer System Local Service Area 601 - Lakeview".
2. The participants in the local service, established under Section 1, are portions of Electoral Areas 'G' and 'Westbank' as shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.

3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Section 823 to be collected by a parcel tax to be imposed in the manner provided by Section 825(2).
 - b) The imposition of fees and other charges that may be fixed by a separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 816 (1) (b) for costs of the service shall be \$12,000.
5. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 601 - Lakeview Establishment Bylaw No. 801 , 1998.


