BYLAW NO. 803

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 683 cited as the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Establishment Bylaw No. 683, 1996" a local service area for the purpose of providing sewer service to a portion of Electoral Area 'G';

AND WHEREAS the Regional Board deems it necessary to amend the said local service area to include:

Remainder of DL 505 ODYD Except Plans 1799, 5015, 7386, 9934, 16222, 20870,
21752, H14757, H16956, 40063.
Lot 146, Plan 5381 DL 2189
Lots 1 - 66, Plan KAS 967, DL 1683
Lot 2, Plan 14095, DL 2189

AND WHEREAS the Regional Board deems it necessary to amend the said local service area to exclude:

Lot 1, Plan KAP 45513 DL 1683 ODYD Except Phase 1 of Plan KAS 967

AND WHEREAS pursuant to Section 812 of the Municipal Act, the Regional Board has obtained a valid petition for the service;

AND WHEREAS it is deemed necessary to amend said Bylaw No. 683 to allow for cost recovery by the imposition of a property value tax;

AND WHEREAS the Director of Electoral Area 'G' has consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1(a) The boundaries are hereby extended to include:

Remainder of DL 505 ODYD Except Plans 1799, 5015, 7386, 9934, 16222, 20870,
21752, H14757, H16956, 40063.
Lot 146, Plan 5381 DL 2189
Lots 1 - 66, Plan KAS 967, DL 1683
Lot 2, Plan 14095, DL 2189

shown as the shaded area on Schedule 'A' attached hereto and forming part of the Bylaw, and to exclude:

Lot 1, Plan KAP 45513 DL 1683 ODYD Except Plan Phase 1 Plan KAS 967

1(b) Section 3(a) is repealed and the following substituted:

- 3. a) The requisition of money under Section 823 to be collected by a property value tax on land only, to be imposed in the manner provided by Section 825(1).


1(c) Section 5 is repealed and the following substituted:

- 5. The maximum amount that may be requisitioned annually under section 816(1) shall not exceed \$120,000.00.
- 2. This Bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Amending Bylaw No. 803, 1998".



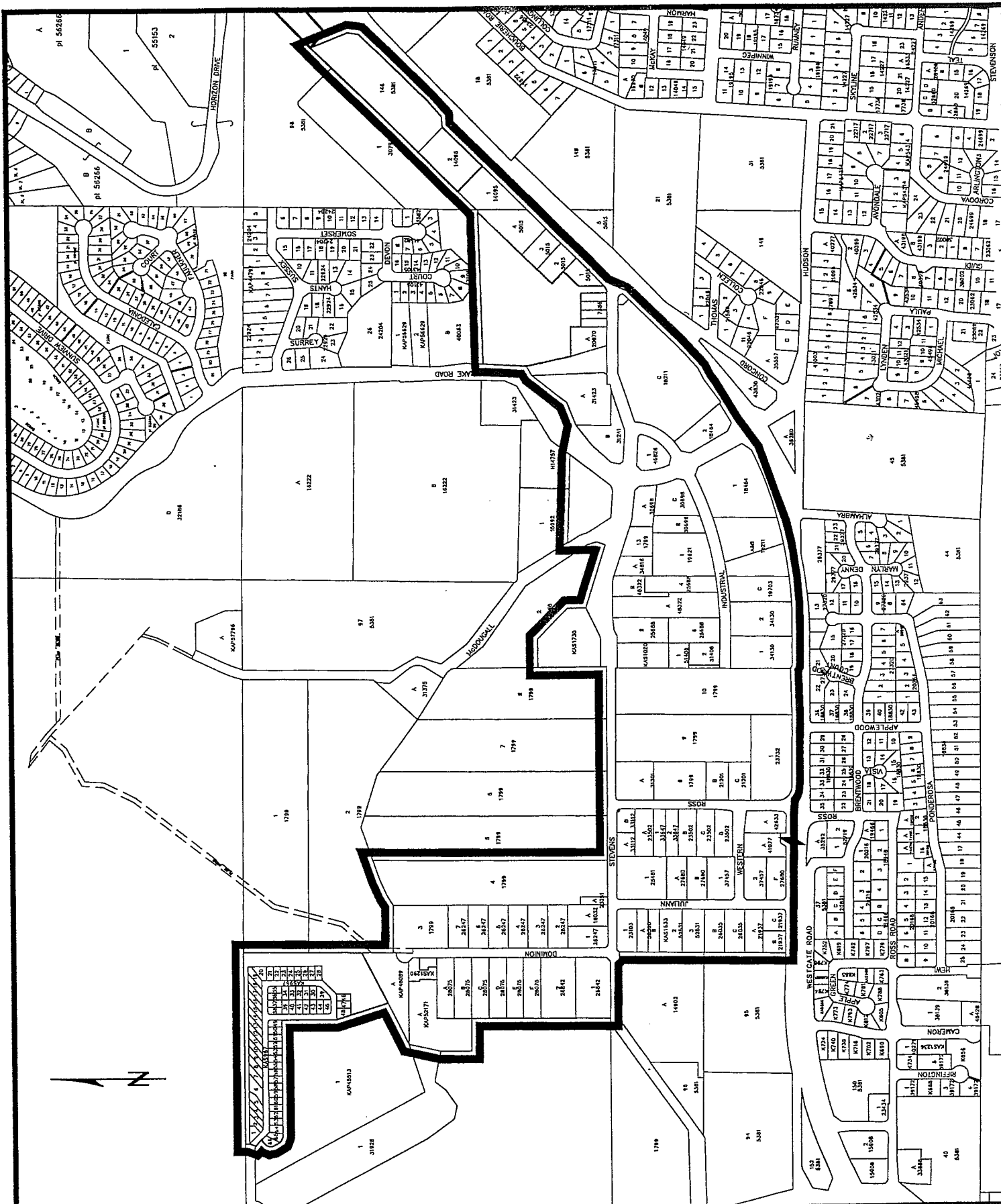
