# REGIONAL DISTRICT OF CENTRAL OKANAGAN

#### **BYLAW NO. 831**

Being a bylaw to establish and operate the extended service of transportation demand management in the Regional District of Central Okanagan.

WHEREAS the Regional District of Central Okanagan has undertaken the preparation of a growth strategy pursuant to Part 25 of the Municipal Act;

AND WHEREAS transportation demand management issues have been determined to be an integral part of the growth strategy;

AND WHEREAS the Board of the Regional District of Central Okanagan deems it advisable to address transportation demand management issues as an extended service of the Regional District;

AND WHEREAS pursuant to Section 800 of the Municipal Act, the Regional District of Central Okanagan has been granted the additional powers to establish the extended service of transportation demand management;

AND WHEREAS pursuant to Section 810 of the Municipal Act, the Council of the City of Kelowna has waived the assent requirements of Section 807(2)(a)(i) of the Municipal Act;

AND WHEREAS pursuant to Section 811 of the Municipal Act, the Regional Board of the Regional District of Central Okanagan has waived the assent requirements of Section 807(2)(a)(i) of the Municipal Act;

AND WHEREAS under Section 811(2) the Directors of Electoral Areas "G", "I" and Westbank have consented in writing to the adoption of the bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

- 1. That the Regional District of Central Okanagan hereby establishes and operates the extended service of transportation demand management.
- 2. That the boundaries in the extended service area established in Section 1 are the boundaries of the City of Kelowna and Electoral Areas "G", "I" and Westbank.
- 3. That the City of Kelowna and Electoral Areas "G", "Westbank" and "I" shall participate in this extended service as participating areas.
- 4. That the annual cost for this service shall be recovered by:

- the requisition of money under sections 822 and 823, to be collected by a property value tax levied and collected under sections 824(1) and 825(1);
- b) the imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.
- 5. That the net cost of providing the service shall be apportioned among the participating areas on the basis of the converted value of land and improvements in the participating areas.
- 6. That this bylaw may be cited for all purposes as "Regional District of Central Okanagan Transportation Demand Management Extended Service Establishment Bylaw No. 831, 1999."
