BYLAW NO. 837

Being a Bylaw to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 366, 1988.

WHEREAS the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Dog Regulation and Impounding Bylaw No. 366 and amendments thereto;

AND WHEREAS it is deemed necessary to amend the said Dog Regulation and Impounding Bylaw;

NOW THEREFORE the Regional District of Central Okanagan in open meeting assemble, enacts the following amendments to Regional District of Central Okanagan Dog Regulation and Impounding Bylaw No. 366;


- 1 Delete Part 11, Section 8(f) in its entirety.
- 2 Delete Part 11, Section 7(a) in its entirety and replace it with the following:
 - i) "Except as allowed by Part II, Section 7(c) and except for veterinary hospitals which keep dogs inside a closed building at all times and other dog service businesses which hold dogs inside a closed building and do not provide overnight care, every person or household which keeps three or more dogs shall obtain a Kennel Operation Permit."
3. Add a new Part II, Section 7(c) as follows:
 - i) "7(c) Required guide dogs (for visual or hearing disabled persons) will not be considered when counting the number of dogs in a household."
4. Add a new Part IV, Section 32(e) as follows:
 - i) "32(e) For the purposes of impound fee calculation, impounds of a dog within the City of Kelowna or within Indian Reserves No. 9 or 10 of the Westbank First Nation shall be included in the impound record of that dog."
5. This Bylaw maybe cited for all purposes as Regional District of Central Okanagan Dog Regulation and Impounding Amendment Bylaw No. 837, 1999.
